ATTENDING: Mayor Ren Hatt, Council Members; Larry Packer, Ben Lehnhoff, and Guy Webster; Planning Commission Members; Gayna Salinas; Employees; Tyler Hunt, Julie Spadafora; Citizens; Lance Erwin, Olive Dunham; Catina Productions; Crystal Bowden.

CONDUCTING: Mayor Ren Hatt, the meeting began at 6:00 p.m.

ABSENT: Bo Harrison and Kent Nelson asked to be excused.

ORDER OF BUSINESS:

1. Discuss/Approve/Deny Contract to purchase water line along Hastings Road
Mayor Ren Hatt spoke, this is a line that has had some issues over the past year as to who owned the line. The city put a water meter in and discovered the city did not own the line, so the water meter was shut off. The city will be purchasing a 6-inch line up to city limits and Donna Hatfield will own and maintain the remainder of the line outside of city limits.
MOTION: made a motion to approve the contract to purchase the water line along Hastings Road, pending attorney review. Ben Lehnhoff seconded the motion. **ROLL CALL VOTE:** Larry Packer, Ben Lehnhoff, and Guy Webster voted aye. The motion carried.
2. Discuss/Approve/Deny Agreements allowing Cantina Productions LLC to lease certain City properties for roughly the months of May and June.
Crystal Bowden with Cantina Productions spoke with the council about a film project coming to the Green River area and about the possibility of leasing the Teen Center and old Fire House for the months of May and June. They will be filming at one of the old gas stations in town and on the Old HWY 6 & 50. Cantina Productions LLC will be leasing some of the City's buildings, for storage of their picture cars and for use of a base camp while filming. **MOTION:** Guy Webster made a motion to approve agreements allowing Cantina Productions LLC to lease certain City properties for roughly the months of May and June. Larry Packer seconded the motion. **ROLL CALL VOTE:** Larry Packer, Ben Lehnhoff, and Guy Webster voted aye. The motion carried.
3. Discuss/Approve/Deny Offering consent to Green River Shootings Sports Park, LLC to lease a portion of the gun range to Cantina Productions LLC
Mayor Ren Hatt wanted to first clarify that the Green River Shooting park is not an LLC, but the Green River Shooting Park Inc. This is just giving consent for Cantina Productions, LLC to lease a portion of the gun range. **MOTION:** Larry Packer made a motion to offer consent to Green River Shooting Park Inc. to lease a portion of the gun range to Cantina Productions LLC. Ben Lehnhoff seconded the motion. **VOTE:** Larry Packer, Ben Lehnhoff, and Guy Webster voted aye. The motion carried.

4. Adjourn, the meeting adjourned at 6:20 p.m.
