CALL TO ORDER AND INTRODUCTIONS

BUSINESS

a. Consider Minutes of March 19, 2024

b. Springdale Transit Line Update

Cameron Cutler, St George City Public Works Director, updated details regarding the public transit line from St. George to Springdale/Zion National Park. Currently 4 of 5 buses are ready to begin running. Cameron shared the proposed location for stops in Hurricane, La Verkin, and Springdale. He also informed everyone that discussions regarding schedules and rates are in process. The anticipated start date is late July 2024.

c. Regional Trail Standards Plan-Status Report

Nate Wiberg-Senior Planner Five County, presented a slide show detailing how the Trail Standards Plan was created. Nate started a discussion on what the committee would like to see as the next steps towards implementation. It was agreed that information would be distributed to the local mayors and draft language for local ordinances would be created.

d. Iron Man Race Update

Chad McWilliams Greater Zion, shared a promotional video created for the Ironman 70.3 race being held on May 4, 2024, in Washington County. Chad informed all in attendance of planned road closures due to the race route. He also encouraged everyone to subscribe to updates via texting GZIRONMAN to 888777. This will send out race day road closure updates. Chad also mentioned the next Ironman will be held May 10, 2025.

SR-18 Rumble strip project will begin after Ironman 70.3 in May.

Mile 3-9 Pavement Preservation will start at the end of April and pause during Ironman race.
