**DISCUSSION:**

**UPHP (0:04)**

Ms. Jacobsen introduced UPHP, formally known as *The Utah Recovery Assistance Program*, as *Utah Professionals Health Program*.

Ms. Jacobsen explained the program is an alternative to public probation to aid licensed healthcare providers with substance use disorders receive treatment.

Dr. Simpson stated the benefit of UPHP, is they can respond to concerns in real time as they are meeting with their participants when needed versus on the quarterly schedule most probations function on.

Dr. Simpson asked the board for their input on the new program and their intended process for their participants.

Dr. Larsen asked how UPHP intends to have licensed professionals join their program.

Ms. Jacobsen explained the way to enter the program is to either self-report, receive a referral from a colleague, or through the investigation process.

Dr. Simpson asked the board for advice on how to make their program know throughout the health professions.

Dr. Campbell stated the most efficient way to spread knowledge of UPHP in the podiatric profession would be to have the Utah Podiatric Medical Association send a letter introducing the program to the profession.
