1. Approval of the January 16th, 2024 meeting:

2. Discuss UFRA Comments and Business:

3. Discuss Forestry, Fire, State Lands Comments and Business:

Jeramy: We have a S270 class that has been scheduled for April 19th and 20th.

Jeramy sent out a nomination form that needs to be filled out so they know how many will be to the class. He wants to have a number before he comes down because he is not going to take more than 20-25 people for the class.

*S212 started last week at the Huntington Fire Station. There were about 12 FireFighters there from the county. It will continue tomorrow night and again on the 22nd. Both days will be 6:00-10:00. The field day will be postponed until we can get into the area.

*Engine Workshop will be a one day workshop. The tentative day is May 11th. It's a Saturday. If chiefs have any suggestions that you want us to teach at this workshop let Jeramy know.

*R2130 class is scheduled for March 13th. If you can't make it to that one we can schedule a date that works for you.

*Any interest for a S131 class? It's a 12 hour class. If you want to put dates together and let Jeramy know, he can look at some dates. He can throw a class together. The sooner the better. The chiefs are thinking March 26, 27, 28th, four hours each day. It will be at the Cleveland Fire Station. The chiefs will take it back to their firefighters and make sure that will work.

*Most engine inspections have been done. When the DOT inspections get done make sure you get a copy to Jeramy so he can update his system.

5. Discuss/Approve/Deny Scott Nelson with Williams on Pipelines in our towns:
