#### 2 GUEST SPEAKER INTRODUCTION

#### 3 CMS GUIDE MODEL GRANT

*Guest, Anne Asman, Program Manager, University of Utah Huntsman Geriatric Psychiatry Clinic*

A presentation was given on the University of Utah Geriatric Psychiatry Clinic's Guiding an Improved Dementia Experience (GUIDE) Model grant. The Centers for Medicare & Medicaid Services (CMS) launched a new voluntary nationwide model, the Guiding an Improved Dementia Experience (GUIDE) Model, on July 31, 2023. The model test intends to benefit people with dementia and their unpaid caregivers. The model will go live on July 1, 2024, for an eight-year period.

The GUIDE Model will focus on dementia care management, with the goal of improving people's quality of life, reducing demand on unpaid caregivers, and allowing individuals with dementia to remain in their homes and communities. These aims will be met through a comprehensive package of care coordination and management, caregiver education and support, and respite programs.

Participants in the GUIDE Model will create dementia care programs (DCPs) that provide ongoing, longitudinal care and support to people with dementia via an interdisciplinary team. GUIDE participants will be Medicare Part B enrolled providers/suppliers, excluding durable medical equipment (DME) and laboratory suppliers, who are entitled to bill for Medicare Physician Fee Schedule services and agree to follow the model's care delivery guidelines.

Fuller Center Collaboration

Through a collaboration with the Fuller Center for Housing in Utah County, the non-profit was able to help a number of MAG Aging and Family Services clients this past year. MAG did an extensive outreach campaign, making clients aware of their home modification and repair services. MAG clients received help such as bathroom remodels, roof replacements and radon remediation.

	<p><i>Jimmy Golding - MAG Co-Deputy Director</i></p> <p>Legislative Update Area Agencies on Aging will receive a total of \$2.4 million in Meals on Wheels funding for vulnerable seniors. MAG hired a lobbyist to assist in obtaining these monies, which proved extremely beneficial.</p> <p>Development Position The Development Director position is presently open and candidates are being interviewed. This position will organize events and campaigns to raise funds for the Meals on Wheels program.</p> <p>March for Meals March for Meals is a month-long fundraising and awareness campaign benefiting our senior nutrition services. From March 18 to 29, mayors and other elected officials from the MAG region will join local volunteers to deliver meals to homebound seniors in their communities. The day provides elected officials with firsthand knowledge of the program's beneficiaries, who are frequently among the most vulnerable and isolated members of their communities. It is a free social engagement opportunity for caregivers that includes complimentary popcorn and beverages.</p> <p><i>Gale Pace, Retired Senior Volunteer Program (RSVP)</i> Confirmed election as 2nd Vice President of Utah Public Employees Association (UPEA). This association represents Utah's public employees. Gale may work as an ambassador for local representatives to ensure Utah's public employees are protected, rewarded, and valued. A Health and Human Services - Out and About grant was received for a new 15-passenger van for the Foster Grandparent Program. The grant is sponsored through donations made to the Out and About funding source.</p>
