In October, the Board Members were provided with a budget comparing the preliminary 2024 budget totals that were adopted in June with the revised 2024 proposed amounts. The changes included an increase in anticipated interest earnings and using the Previous Fund Balance. The Trustees had no questions about the 2024 LBA proposed budget, and no members of the public were present.
