

RESOLUTION NO. 24-06-06 B

A RESOLUTION ADOPTING A TENTATIVE BUDGET FOR THE PERIOD OF JULY 1, 2024 THROUGH JUNE 30, 2025; PROVIDING FOR PUBLIC INSPECTION OF SUCH BUDGET; ESTABLISHING THE TIME AND PLACE OF PUBLIC HEARING TO CONSIDER ADOPTION OF SUCH BUDGET; AND PROVIDING FOR PUBLICATION OF NOTICE OF SUCH PUBLIC HEARING

WHEREAS, the Uniform Fiscal Procedures Act for Utah Cities §10-6-101 provides, among other things, that (a) the mayor or other budget officer shall propose a tentative budget for the upcoming fiscal year to the town's governing body; (b) the town's governing body shall review, consider (and amend, as advisable) and tentatively adopt such tentative budget; (c) such tentative budget shall be available for public inspection for at least ten days prior to adoption of a final budget; (d) the town's governing body shall hold a public hearing concerning the tentative budget following at least seven days of public noticing as provided in §63G-30-102; and (e) following such public hearing, the town's governing body may adopt a final budget as provided in the Act; and

WHEREAS, at a meeting of the town council (the "Council") of the Town of Hinckley, Utah on May 16, 2024, Chris Palmer, the Town's treasurer, filed with the Council a tentative budget for the Town for the period of July 1, 2024 through June 30, 2025.

WHEREAS, as part of its May 16, 2024, regular meeting, the Council reviewed and considered the proposed tentative budget for the upcoming fiscal year; and

WHEREAS, the Council desires to fully comply with the requirements of the Act regarding adoption of a final budget for the Town; and

WHEREAS, after careful consideration, the Council has determined that it is in the best interest of the health, safety and welfare of the citizens of the Town to tentatively adopt the Tentative Budget as presented by the Town's treasurer;

NOW, THEREFORE, BE IT RESOLVED by the town council of the Town of Hinckley that the Council hereby (a) tentatively adopts the Tentative Budget; (b) orders that a public hearing concerning the Tentative Budget be held on Thursday, June 20, 2024, beginning at 7:00 p.m., or as soon thereafter as practical, at 161 E. 300 N., Hinckley, Utah at which time all interested persons in attendance shall be given the opportunity to be heard, for or against, the Tentative Budget; (c) orders that a copy of the Tentative Budget be available for public inspection at the Town Office at 161 E. 300 N., Hinckley, Utah for at least ten days prior to the Hearing; and (d) orders the Town Clerk to assure that, starting at least seven days before the Hearing and continuing until the hearing occurs, notice of the Hearing is: (i) posted in at least three public locations within the Town (Hinckley Post Office, Town Office, Advertisement Board at 12 E. 500 N., Hinckley); (ii) published on the Utah Public Notice Website; and (iii) published on the home page of the Town's website.

This Resolution, assigned no 24-06-06 B, shall take effect immediately upon passage as provided herein.


