Agenda Item 3	<p>3. Shelter City Highlights</p> <p>a. Logan</p> <p>There were some scheduling and technical difficulties for those presenting from Logan. This presentation will be moved to a later meeting.</p> <p>b. St. George</p> <p>St. George's first homeless shelter was called Dixie Care and Share. The facility was no longer serving the community and the city purchased a new building which they now lease to Switch Point for \$1/year for about 10 years. They have been full since the time they opened. Switch point just recently purchased some property to open a separate food pantry and are looking at other property to expand their shelter availability. The current Switch Point shelter has 84 beds, and are looking to add more beds for families and reach 110 total beds. The police department mountain bike unit has been helpful keeping camping at bay. Even if an individual is not staying at the shelter, they can take advantage of different services offered. One of the challenges St. George is having, is not being able to count any of the homeless population on the Arizona strip in the point in time count. Mitigation Funding Update</p> <p>Tricia reviewed the Utah state code linked <a href="#">here</a>. The Office of Homeless Services goal with the application process for mitigation funding is to meet all of the requirements that are in this State statute and help municipalities meet those requirements through a streamlined process.</p> <p>Meredith Vernick gave an update on where the Office of Homeless Services is at in the process in regards to the funding opportunity. The mitigation account for FY 25 is just over 17.3 million. Tier one counties host eligible shelters with 80 or more beds, 365 days per year, and tier 2 is 25 beds. The 17.3 million is split amongst the 3 tiers tier 3 being for winter response. 87.5% of that bucket goes directly to first tier cities. 2.5 million goes to the second tier, and then 10% is set aside for winter response. On May 16th they will be seeking approval from the UHSB on both the funding opportunity and the amount. Going to each eligible city. As far as what the application will look like, they have essentially taken applicable mitigation code, and turned it into questions, and there shouldn't be any major surprises. They anticipate the application to be released on May 17<sup>th</sup> and due on May 31<sup>st</sup>. Cities will present to the UHSB board in their June meeting.</p>	Tricia Davis

Their first joint public meeting with the public, planning commission, and City Council will be held May 29<sup>th</sup>.</p> <p>Mayor Marcus Stevenson of Midvale shared an update on their asylum population at the Midvale Family Shelter. They were able to approve some funds from their RDA to help move those families into temporary motels and hotels. Most of them are still in Midvale, and then the road home is continuing to do case management. The States really stepped up and is helping a lot, too. There's been a lot of community partnership there and Salt Lake County is continuing to hold regular stakeholder meetings every other week, where they're talking about this on a broader scale. Trying to be prepared for some of the challenges that will come as we see more and more migration.</p>
