**Mr. David Delquadro** led the Pledge of Allegiance to the Flag of the United States of America.

## 2. PUBLIC COMMENT

**Ms. Karen Wyatt**, a violinist with the Utah Symphony, spoke about the significance of Abravanel Hall to Utah residents. She thanked Mayor Jennifer Wilson for her commitment to keeping Abravanel Hall, which was specifically built to showcase and enhance live orchestra music, in its current form. She noted it would cost an estimated \$400 million to make good on the promise that was made in the joint statement that was released last week by the Mayor, Smith Entertainment Group, and the Utah Symphony.

**Mr. Keith Carrick**, a percussionist with Utah Symphony, stated it was vital that Abravanel Hall maintain its excellent acoustics. The Utah Symphony is one of only 15 full-time orchestras in the United States. It has served the people of Utah for 85 years and has performed for nearly every child in the state for the last 50 years. The County has an interest in maximizing revenue from the hall, and this can be done with a phased approach to save money. A re-build could result in being without a venue for many years. The Utah Symphony will exist for years to come.

**Mr. Allen Roberts** stated the question was not whether to keep Abravanel Hall, but how to best do it. The easiest way to get a building destroyed is to use exaggerated scopes and estimates to claim the project is too costly. Estimates are only as valid as the information is specific. There are many more goal-satisfying options than those already given. He asked the Council to create an independent committee of experts to explore options on a cost-benefit basis.

**Mr. Drew Fallon** spoke against demolition of Abravanel Hall because community impact cannot be taken for granted. The symphony industry has fallen over the past several years, and Abravanel Hall is one of the last bastions. The desired goals can be accomplished without demolishing the hall.

**Ms. Sylvia Miera Fisk** of the Utah Gay Straight Coalition read the following statement and requested that it be made part of the record in its entirety.

*Council member Aimee Winder Newton frivolously tried to pull me into a lawsuit where she is being sued for defamation and conspiracy by a gay man.*

*I filed what is called a UPEPA motion in response to Winder Newton's frivolous attempt to pull me into a lawsuit. Let me start by reading to you some of the judge's statements during the hearing on our motions:*

- Judge Lawrence stated, "I have no idea what Ms. Winder Newton thought she was going to gain by bringing a lawsuit against a third party who is making a statement of opinion and concern to Sim Gill. This just seems so **unseemly** to me that a sitting politician would try to sue somebody for making a comment to them publicly."
- Judge Lawrence also stated, "It is odd for a politician to assert a claim against somebody who is labeled a concerned citizen."
- Judge Lawrence found that Winder Newton's "...Third Party claims were infirm . . . to the extent there are any claims against Ms. Fisk, they are dismissed without prejudice.

*I won, and Winder Newton lost. The judge was clearly flabbergasted by Winder Newton's unseemly actions. Unfortunately, the judge did not rule on my UPEPA motion, which means I am saddled with tens of thousands of dollars in legal fees.*

*I am a single grandmother, a lower-middle-class woman living off social security. I am appealing the judge's decision not to rule on my UPEPA motion. If I do not appeal, citizens in Utah will be at risk of being sued for exercising their First Amendment rights.*

*A couple of questions I have for Council member Winder Newton are:*

- *Did you sue me because I ran for governor against your boss? Or*
- *Did you sue me to intimidate and silence me because I asked questions about your actions as an elected official who attacks and destroys the lives and reputations of*

*citizens with whom you disagree?*

*I want to note that this County Council can censure its members. It would be appropriate for you to censure Winder Newton for filing this frivolous lawsuit against me.*

**Mr. Goud Maragani** of the Utah Gay Straight Coalition read the following statement and requested that it be made part of the record in its entirety.

*My name is Goud Maragani. I am the chairman of the Utah Gay-Straight Coalition.*

*Yesterday, I got a call from Senator Bramble about Utah's UPEPA statute. This is a statute that is supposed to protect regular citizens when rich and powerful people sue them to silence and intimidate them. If you win a UPEPA motion, your case will be dismissed with prejudice, and you will get attorney's fees. For example, it should have protected Sylvia from Council member Winder Newton's frivolous lawsuit.*

*During our conversation, Senator Bramble repeatedly said that Winder Newton was suing Sylvia in her personal capacity. I am not sure how he knows whether Winder Newton is suing Sylvia in her personal capacity because we have no idea who is paying for Winder Newton's attorney, Melinda Bowen.*

*Melinda Bowen used to work at the Salt Lake County DA's office and now works at a private law firm. She represents Winder Newton with regard to the frivolous counterclaim and motion for joinder that Winder Newton filed against Sylvia. Bowen also represents Winder Newton, Council member Stringham and Abby Evans in other counter claims that were filed in the lawsuit.*

*Since DA Sim Gill is here, I was hoping he could answer some questions:*

- *Are County taxpayers paying Ms. Bowen's legal fees with regard to the frivolous counterclaim and motion for joinder to bring Sylvia into Robinson v. Winder Newton, et al, Case No. 220900591 in the third district court?*
- *Winder Newton sued Sylvia at least partially based on a question that was in an email Sylvia sent to DA Sim Gill. Did DA Sim Gill inform Winder Newton of Sylvia's question to Sim Gill about Winder Newton.*
- *Did Sim Gill suggest or recommend that Winder Newton sue Sylvia? If yes, how did he arrive at the recommendation?*
- *What specifically was the purpose of Winder Newton's suit against Sylvia? Was it*

*election interference? Was it intimidation and an effort to silence Sylvia?*

- *In the main lawsuit, the Salt Lake County DA's office is representing Winder Newton, Councilmember Stringham and Abby Evans.*
- *Did the DA's office or the County Council conduct an analysis to determine whether the actions at issue in the lawsuit were in each individual's capacity as an elected official or county employee or as a member of the Salt lake County Republican party? If yes, can we see the analysis? This is important because taxpayers shouldn't be paying to defend elected officials and govt employees in their personal lawsuits.*

*Finally, Winder Newton recently posted on X that she is one of dozens of elected officials in Utah who contacted the National Log Cabin Republicans to pressure them to shut down our local chapter. Shortly thereafter, our chapter was terminated.*

*Is there a formal process with the County where I can file a complaint to have Winder Newton's action investigated. If yes, please direct me to the process.*

**Mr. Frederick Jenny** spoke about the Rio Grande plan, which is a citizen proposal to bury the railroad tracks throughout downtown Salt Lake City in a below-grade structure called a train box. The plan is widely supported, and the city has performed a cost-impact analysis. He urged the Council to adopt this plan so that the city does not become inundated with cars. The railroad tracks divide the city and prevent people from being able to use the facilities.

**Ms. Charmonix Larsen**, President, American Institute of Architects, read, a letter approved by the Board opposing the possibility that Abravanel Hall could be demolished or gutted. The full letter is on file with the official meeting minutes at the Salt Lake Council Clerk's Office.

**Ms. Geneva Lawrence** spoke of the value of having a symphony for the education and development of future artists. She introduced her son, David Lawrence, who was admitted to the Cleveland Institute of Music due in part to growing up in a city with an excellent symphony and symphony hall.

**Ms. Angel Vice**, Millcreek Arts Council, spoke in favor of keeping Abravanel Hall because the County needs more performance spaces. The size is perfect, and it is a gift to the community.

**Ms. Barbara Scowcroft**, a violinist with the Utah Symphony, read a statement from a high school student, Octavia Patano.

*In fifth grade, along with every other ten year old in the district, I went to Abravanel Hall for the first time. I was instantly enamored. I was in awe of the Chihuly, the gold leaf, and the chandeliers. My parents were trying to get me to play an instrument at the time, and I didn't understand why they felt it would be good. I had never been to a symphony before so when the Utah Symphony started to play, I finally understood. I went home that night and told my mom I was going to play the cello. When I was a Junior in High School, I joined the Utah Youth Symphony and was lucky enough to perform at Abravanel Hall. I would not have had the opportunity to play there if it had not inspired me in the first place. I know I'm not the only musician who has been inspired to start an instrument because of the hall. In my Senior year, I wrote about this experience and how much the hall means for me as my college application essay. Abravanel Hall helped me be accepted to five schools, including the University of Glasgow, demonstrating that the hall's reach extends throughout the globe. If the hall were to be torn down, the physical manifestation of my inspiration would be destroyed. Please don't take away the opportunity for other musicians to be inspired like I once was.*

**Sheriff Rosie Rivera** reviewed the increase request, which was a 2.14 percent increase in the retirement contribution for all sworn Tier II employees. This will cover the increase calculated by Utah Retirement Systems (URS). As of May 7, 2024, the Sheriff's Office has 359 active sworn employees under the Tier II retirement plan, and 51 vacant sworn positions.

**Mr. Zachary Stovall**, Fiscal Administrator, Sheriff's Office, stated the total impact would be about \$640,000 on an annualized basis. This adjustment would be part of the upcoming June budget.

**Darrin Casper** stated there would be an additional estimated earmark of \$400,000 set aside.

**Council Member Winder Newton** asked if most of the other local police agencies were going to cover this increase.

**Sheriff Rivera** stated they were.

**Council Member Bradshaw** asked why this was being approved today if it was to be part of the June budget process.

**Mr. David Delquadro**, Chief Financial Manager, Council Office, stated it was to signal to the employees transitioning from the Unified Police Department to the Sheriff's Office that they would not lose out due to the 2.14 percent increase. Today's vote was not to provide funds, but assurance.

**Ms. Erin Litvack**, Deputy Mayor of County Services, stated reviewed the project partners for the 2024 Maurice Abravanel Hall Master Plan.

**Ms. Robin Chalhoub** stated the plan was an accumulation of several studies performed over the past few years. This included the 2016 Abravanel Hall Master Plan; the 2021 Utah Symphony Utah Opera Strategic Plan; the 2022 HVAC study for the Salt Palace, Utah Museum of Contemporary Art (UMOCA), and Abravanel Hall; and the 2022-2023 UMOCA Master Plan. The entire master plan document, along with attachments, could be viewed at saltlakecountyarts.org.

**Mr. Steve Brosvik**, President and Chief Executive Officer, Utah Symphony and Utah Opera, stated the Utah Symphony and Utah Opera's mission was to connect people through great live music. Eighty percent of the current plan was finding active ways to engage audiences. Audience needs and expectations have continued to change.

**Mr. Matt Castillo**, Director, Arts and Culture Division, spoke about the community outreach aspect of the master plan. This included many in-person roundtable discussions, online surveys, interviews with key stakeholders, and analysis of patron venues.

**Mr. John Sparano**, Principal Architect, Sparano + Mooney Architecture, concluded the presentation, reviewing the seven general key findings of the masterplan, the project scope, and the test fit and cost estimates for options A and B.

**Council Member Granato** asked what needed to be done immediately versus what could wait. She also asked if there had been any consideration

of the use of a bond to fund the necessary renovations.

**Jeff Gwilliam**, Associate Division Director of Theater Operations, Arts and Culture Division, spoke about the plans to update the HVAC system.

**Mayor Jennifer Wilson** stated there was not an identified revenue stream. The Zoo, Arts & Parks (ZAP) program funds operations for the symphony, but cannot fund capital costs.

**Council Member Winder Newton** asked how much was in the annual deferred maintenance budget.

**Ms. Erin Litvack**, Deputy Mayor of County Services, stated the Tourism, Recreation, Cultural and Convention (TRCC) Fund had about \$8 million set aside annually. This was for all the deferred maintenance for both Arts and Culture, Parks and Recreation, and the Planetarium.

**Mr. Darrin Casper**, Deputy Mayor of Finance and Administration, stated debt for a \$200 million project would amount to \$15 million per year. Many of the special funds the County has would be insufficient to fund this project. Absent an additional revenue source, it would probably be a General Fund expenditure.

- E. The County desires the construction of street improvements, including a paved road, curb, gutter, and sidewalk to the City’s roadway standard, and the installation of required utility infrastructure to the City’s required standard (the “Street Improvements”).
- F. As set forth in the Right-of-Way Construction Agreement, attached hereto as Exhibit 1 (the “Right-of-Way Agreement”), Evergreen will construct the Street Improvements, and upon completion, the County will dedicate the Street Parcel to the City.
- G. Under the Agreement, the County will grant a temporary construction easement, a permit for a turnaround area, and a license for a staging area to Evergreen, and Evergreen will tear down some derelict buildings on the County Property in addition to the construction of the Street Improvements.
- H. The Agreement provides a mutual benefit to the County and Evergreen and will facilitate future development of the County Property and the Evergreen Property.
- I. It has been determined that the best interest of the County and the general public will be served by entering into the Right-of-Way Agreement and associated documents. This action will comply with all applicable state statutes and County ordinances.

## RECITALS

A. Salt Lake County (the "County") owns certain real property located at approximately 2880 West 3650 South, West Valley City, Utah, also identified as Parcel No. 15-33-128-045 (the "Property"), which is the West Valley Branch of the Salt Lake County Library.

B. West Valley City (the “City”) is constructing roadway improvements along 3650 South Street (the “Project”) and would like to acquire a 2,739 -square-foot portion of the Property (the “Parcel”) from the County and a temporary construction easement as part of the Project.

C. On March 26, 2024, the Salt Lake County Council (the “Council”) approved Resolution 6188, declaring the Parcel available for disposal and authorizing execution and delivery of a Real Estate Purchase Contract (the “March REPC”) to the City for the transfer of the Parcel.

D. After approval of Resolution 6188, the City withdrew the March REPC because it contained an erroneous appraisal value for the Parcel. A portion of the Parcel is located within the existing right-of-way and is currently occupied by existing street improvements, which was not accounted for in the calculation of value. The City does not need to pay for the portion of Parcel that is already located in the public right-of-way.

E. The size and shape of the Parcel has not changed, but the appraised value has changed to reflect only the amount required to be paid for the portion of the Parcel outside of the existing right-of-way.

F. The City has submitted a corrected Real Estate Purchase Contract (the “Corrected REPC”) to the County for the acquisition of (1) the Parcel via a quit claim deed (the “Deed”) and (2) the temporary construction easement via a separate document (the “Easement”).

G. The corrected amount offered by the City for acquisition of the Parcel and the Easement is \$30,300.00, which amount has been reviewed and approved by the Salt Lake County Real Estate Section as full and adequate consideration.

H. The Salt Lake County Library Board concurs with this conclusion and has recommended approval the transfer of the Parcel to the City as provided in the Corrected REPC.

I. It has been determined that the best interests of the County and the general public will be served by executing the Corrected REPC, the Deed, and the Easement. These actions will be in compliance with all applicable state statutes and county ordinances.




