**BE IT RESOLVED** that the Orangeville City Council on this 13<sup>th</sup> day of June, 2024 did unanimously approve the following budgets:

**BE IT FURTHER RESOLVED** that the 2024-2025 Orangeville City's **GENERAL FUND BUDGET** be adopted as follows:

General Fund Revenue Budget	\$1,054,483.00
General Fund Expenditure Budget	\$1,054,483.00

**BE IT FURTHER RESOLVED** that the 2024-2025 Orangeville City's **UTILITY BUDGET** be adopted as follows:

Utility Revenue Budget	\$323,000.00
Utility Expenditure Budget	\$290,300.00

**BE IT FURTHER RESOLVED** that the 2024-2025 Orangeville City's **MUNICIPAL BUILDING AUTHORITY FUND BUDGET** be adopted as follows:

Building Authority Revenue Budget	\$22,000.00
Building Authority Expenditure Budget	\$22,000.00

**BE IT FURTHER RESOLVED** that the 2024-2025 Orangeville City's **CAPITAL PROJECTS BUDGET** be adopted as follows:

Capital Projects Revenue	\$5,000.00
Capital Projects Expenditures	\$50,000.00

**BE IT FURTHER RESOLVED** that the 2024-2025 Orangeville City **PERPETUAL CARE BUDGET** be adopted as follows:

Perpetual Care Fund Revenue	\$16,000.00
