

ORDINANCE 2024-12

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF NORTH OGDEN, UTAH ENACTING COMPENSATION INCREASES FOR SPECIFIC CITY OFFICERS

WHEREAS, the Utah State Legislature during the 2024 General Session passed S.B. 91;

WHEREAS, S.B. 91 amended Utah Code Section 10-3-818 regarding City employee salaries; and

WHEREAS, North Ogden City must now publish public notice and hold a separate public hearing on proposed compensation increases for executive municipal officers before adopting those increases; and

WHEREAS, the North Ogden City Council finds that enacting the proposed compensation increases as set forth in this Ordinance will comply with Utah Code requirements and will promote the public health, safety, and welfare of the residents of the City of North Ogden City, Utah.

NOW, THEREFORE, BE IT ORDAINED by the North Ogden City Council by the authority of Utah Code 10-3-818, that the following salaries are adopted.

SECTION 1: Enactment of Compensation

The attached Exhibit A contains compensation increases for executive municipal officers proposed for inclusion in the City's Fiscal Year 2025 budget.

SECTION 2 : This ordinance shall take effect on June 30, 2024
