## **Dimple Dell Preservation Committee Earth Day Report**

*Sandra Haak Dimple Dell Preservation Committee*

- Report on incident at Muir-Poulsen House, wanting to add security lighting or cameras.  
*Sandra Haak and Joyce Walker talked about Muir -Poulsen house and an incident that happened with some teenagers. They want to advocate for a security system or motion activated lights to protect the house and what the county will approve. They feel like this has become an urgent issue.*
- *The DDPC had put caution tape around the trees they had planted during the Earth Day event. The caution tape had been removed which was frustrating.*
- *The DDAB Board talked about writing a letter to the County recommending security lights and cameras at the Spencer House and the Muir-Poulsen House. Explore options and cost for implementing a security system at the Paulson Orchard house to protect against potential damage (advocate for funds, research camera options, discuss with County)*
- *Joyce Walker talked about the earth day clean up and the ribbon cutting. The signup sheets indicated 275 people showed up to volunteer. The Parks crew was phenomenal. Joyce Walker felt that there was a lot of weed and trash removal. Next year the 9<sup>th</sup> annual will be on Saturday April 26. Fifty pounds or more native seeds were dispersed. Joyce Walker commented that it was an orderly well-run event and thanked everyone who volunteered their time.*
