MINUTES

A motion was made by Bryan Romney to approve the minutes from the April 11, 2024 meeting as written. The motion was seconded by Willie Chidester and passed unanimously.

MAKE A DECISION ON ARTICLE 210.8(A)(5)

The committee reviewed the current amendment for this article. Following the discussion a motion was made by Will Pierce to keep the current amendment as written. The motion was seconded by Bryan Romney and passed unanimously.

The committee started their review of Chapter 3. Each change was reviewed to determine if an amendment was necessary and if there was a cost impact.

During the review of Article 314.27(C) and the current amendment for this article, the committee discussed the the cost and the safety of ceiling fan boxes. Following the discussion, a motion was made by Bryan Romney to delete the current state amendment and adopt the 2023 language for Article 317.27(C). The motion was

seconded by Chris Chadwick and passed unanimously.

Article 334.24 was reviewed for a possible amendment. Following the review, Ryan Jackson will bring some wording to the next meeting for the committee to review and consider an amendment. He will also bring the wording for a possible amendment to Article 338.24.

The committee agreed that most of the changes to the articles in Chapter 3 were for clarification and did not add any new requirements or costs.

The committee started the review of Chapter 4 and in looking at the new wording for Article 406.9(B) it was decided that they will need to consider making an amendment to change it back to the wording from the 2020 NEC. This will be decided on at the next meeting.

The meeting adjourned at 4:45.
