## **REQUEST**

Consideration of a resolution adopting the 2024 Certified Tax Rate as calculated by Utah County.

## **BACKGROUND & DESCRIPTION**

Each year the city is required to certify the tax rate. Utah County has provided staff with the new assessed values. These values decreased from last year which caused Utah Counties proposed rate to increase from last year. Staff recommends adopting the counties proposed rate to avoid lost revenue caused by the decrease in assessed values.

Budgeted Property Tax revenue is increasing due solely to growth in population. The total revenue will be \$3,187,543.
