LOCAL REFERENDUM APPLICATION

TO PLACE A CITIZEN'S REFERENDUM TO REPEAL RESOLUTION #5-21-2024 R1.

On May 21, 2024, the Board of Commissioners of Uintah County, Utah adopted Resolution #5-21-2024 R1, A RESOLUTION OF THE UINTAH COUNTY COMMISSION AUTHORIZATION OF THE IMPOSITION OF A 0.3% LOCAL OPTION SALES TAX FOR PUBLIC SAFETY UNDER UTAH CODE ANNOTATED (UCA) 59-12-2216.

The undersigned residents of Uintah County, Utah respectively submit the Referendum Application in response to adoption of Resolution #5-21-2024 R1. The proposed referendum will ask Uintah County residents to repeal the Board of Commissioners of Uintah County, Utah enactment of Resolution #5-21-2024 R1, with the result of <u>not</u> imposing a 0.3% Sales & Use Tax for Public Safety.

UINTAH COUNTY RESOLUTION #5-21-2024 R1

A RESOLUTION OF THE UINTAH COUNTY COMMISSION AUTHORIZATION OF THE IMPOSITION OF A 0.3% LOCAL OPTION SALES TAX FOR PUBLIC SAFETY UNDER UTAH CODE ANNOTATED (UCA) 59-12-2216.

Whereas, Uintah County is authorized to impose a Local Option Sales Tax for Public Safety Purposes under UCA 59-12-2216 (3)(b); and

Whereas, there is an ongoing and acute need for Funding for Public Safety Purposes; and

Whereas, UCA 59-12-2216 (1) provides for the imposition of up to 0.3% sales and use tax for Public Safety Purposes; and

NOW THEREFORE, it is hereby resolved by the Uintah County Board of Commissioners to impose a 0.3% sales and use tax for Public Safety Purposes as permitted under UCA 59-12-2216. Said sales and use tax will be enacted by the Utah State Tax Commission and allocated 100% for the purpose of public safety to Uintah County upon passage of this resolution. Effective date for tax implementation, October 1st, 2024.

Uintah County- Initial Fiscal and Legal Impact Statement UCA 20A-7-602.5

- This fiscal and legal impact statement prepared on behalf of Uintah County as presented regarding Resolution #5-21-2024 R1, approved on May 21, 2024, for the purpose of imposing a 0.3% Sales and Use Tax for Public Safety purposes as permitted under UCA 59-12-2216. The fiscal impact of repealing Resolution #5-21-2024 R1 is estimated to be a \$4,485,000 loss in revenue intended solely for the purpose of Public Safety. Specifically referring to the services involving the Uintah County Jail and the Uintah County Sheriff Department.
- ii. Repealing Resolution #5-21-2024 R1 would decrease the County sales tax by 0.30%, an estimated revenue of \$4,485,000.
- iii. Repealing Resolution #5-21-2024 R1 would result in no change in the issuance or status of bonds, notes, or other debt instruments.
- iv. The repeal of Resolution #5-21-2024 R1 will result in an estimated loss of \$4,485,000 for public safety services that will have to be funded by property tax.
- v. The repeal of Resolution #5-21-2024 R1 will cost the County \$4,485,000 to provide Public Safety services to the citizens of Uintah County. The approved 2024 budget for Public Safety services for the Sheriff and Jail alone are \$14,584,500. Revenues from Public Safety services are \$4,518,900 leaving expenses over revenues of \$10,065,000. The County is currently funding this short fall with \$3.5 million from savings. Property tax and other sales tax cover the balance. This will secure funding for Public Safety without the use of savings.
- vi. There are no legal impacts that would result from repealing Resolution #5-21-2024 R1.
- vii. Concise explanation of the information described in this section and estimated fiscal impact if repealed.

If Resolution #5-21-2024 R1 is repealed, the imposed 0.3% Sales and Use Tax will not provide Public Safety with the estimated \$4,485,000 in revenue for ongoing expenses for the Uintah County Jail and the Sheriff Department. Public Safety is a crucial service to the community. Considering inflation, demand for services, and other unknown future events, Resolution #5-21-2024 R1 is expected to reduce the deficits that are not currently being covered by revenues the Jail and Sheriff generate. This Resolution is intended to help Public Safety with specific funds for growth, safety, and security for the citizens of Uintah County.

Re: Legal Referability of Proposed Referendum of Uintah County

Resolution #5-21-2024 R1

FACTS

On May 23, 2024 the Uintah County Clerk-Auditor's Office received an application from certain sponsors, entitled "Local Referendum Application" This was then forwarded, same day, to the Uintah County Attorney's Office.

QUESTION PRESENTED

Under U.C.A. \$20A-7-602.7(1), the Uintah County Attorney's Office, as counsel for Uintah County, is charged with the high responsibility to determine whether the proposed referendum is legally referable to voters.

ANALYSIS

Pursuant to U.C.A. §20A-7-602.7, "a proposed referendum is legally referable to voters unless:

- (a) The proposed referendum challenges an action that is administrative, rather than legislative, in nature;
- (b) The proposed referendum challenges more than one law passed by the local legislative body; or

(c) The application for the proposed referendum was not timely filed or does not comply with the requirements of this part."

Nature of Action

The power to tax is one of the most fundamental legislative powers authorized by the Utah Constitution. Additionally the statute granting authority to counties to impose this tax repeatedly authorizes the "county legislative body" to impose such tax. $U.C.A.\ 59-12-2216.$ Therefore it is clear on the face of the statute that this is a legislative action.

Number of Challenged Laws

The Local Referendum Application only challenges one law, as authorized by the Utah State Legislature, Uintah County Resolution #5-21-2024 R1.

Timeliness

The resolution in question was adopted by the Uintah County's legislative body on May 21, 2024. U.C.A. 20A-7-601 requires an application challenging a local law passed by the legislative body to be filed within five days after the day on which the local law was passed. The application was received by the Uintah County Clerk-Auditor on May 23, 2024. Therefore, timeliness is not questioned here.

Compliance With Part 6 of Title 20A Chapter 7

U.C.A. \$20A-7-602(2) requires the following to be included in the application:

- (a) The name and residence address of at least five sponsors of the referendum petition;
- (b) A statement indicating that each of the sponsors is registered to vote in Utah;
- (c) A statement indicating whether persons gathering signatures for the petition may be paid for gathering signatures;
- (d) The signature of each of the sponsors, acknowledged by a notary public; and
- (e) (i) if the referendum challenges an ordinance or resolution, one copy of the law

It appears on the face of the application that all five requirements above were met.

CONCLUSION

After careful analysis of application and relevant statutes, the action taken by the Uintah County Commission in adopting Uintah County Resolution #5-21-2024 R1 is legally referable to the voters.
