ORDINANCE 2024-14: AN ORDINANCE OF OGDEN CITY, UTAH, ADOPTING THE PROPOSED TENTATIVE BUDGET OF OGDEN CITY FOR FISCAL YEAR 2024-2025.

ORDINANCE 2024-15: AN ORDINANCE OF OGDEN CITY, UTAH, AMENDING THE OGDEN MUNICIPAL CODE BY AMENDING SECTION 9-2-8 TO REVISE PRIVATE FIRE PROTECTION SYSTEMS REGULATIONS; BY MAKING TECHNICAL CHANGES; AND BY PROVIDING THAT THIS ORDINANCE SHALL BECOME EFFECTIVE IMMEDIATELY UPON POSTING AFTER FINAL PASSAGE.

ORDINANCE 2024-16: AN ORDINANCE OF OGDEN CITY, UTAH, AMENDING THE OGDEN MUNICIPAL CODE BY AMENDING SECTION 9-1-6 TO REVISE UTILITY RATES AND BILLING; TO MAKE TECHNICAL CHANGES; AND BY PROVIDING THAT THIS ORDINANCE SHALL BECOME EFFECTIVE IMMEDIATELY UPON POSTING AFTER FINAL PASSAGE.

ORDINANCE 2024-17: AN ORDINANCE OF OGDEN CITY, UTAH, APPROVING THE CAPITAL IMPROVEMENT PLAN FOR OGDEN CITY FOR THE FISCAL YEARS 2025 TO 2029, AND PROVIDING THAT THIS ORDINANCE SHALL BECOME EFFECTIVE IMMEDIATELY UPON POSTING AFTER FINAL PASSAGE.

ORDINANCE 2024-20: AN ORDINANCE OF OGDEN CITY AMENDING THE BUDGET FOR THE FISCAL YEAR JULY 1, 2023 TO JUNE 30, 2024 BY INCREASING THE ANTICIPATED REVENUES FOR A GROSS INCREASE OF \$5,819,050 FROM SOURCES AS DETAILED IN THE BODY OF THIS ORDINANCE; AND INCREASING THE APPROPRIATIONS FOR A GROSS INCREASE OF \$5,819,050 AS DETAILED IN THE BODY OF THIS ORDINANCE; AND PROVIDING THAT THIS ORDINANCE SHALL BECOME EFFECTIVE IMMEDIATELY UPON POSTING AFTER FINAL PASSAGE.
