REPORT AND CONSIDERATION OF 2024 WASHINGTON COUNTY TAX SALE

Clerk-Auditor Ryan Sullivan reported on three properties that were sold during the 2024 Tax Sale. Two properties, parcels 4191-A-2-L-HV and H-GANV-B-15-A were sold at auction. Any excess funds collected over the amount owed are allocated to the recorded lien holders or property owner.

Mr. Sullivan requested that property W-208-C be stricken to Washington County, as it is a portion of a roadway in Washington City. Washington County will communicate with Washington City to deed this roadway portion to the City.

CONSIDERATION OF THE 2024 CERTIFIED TAX RATES FOR WASHINGTON COUNTY

Mr. Sullivan explained the certified tax rate for Washington County will be as follows: General Operations rate is 0.000373; the Interest and Sinking Fund/Bond is 0.000010; the Library Rate is 0.000129 for a total budgeted revenue of \$18,888,179. The County Assessing & Collecting Rate is 0.000230 for a total budget of \$8,589.926.

Deputy County Attorney Devin Snow stated that Washington County has recognized this holiday since 2022, but this is the first time there has been a Proclamation regarding Juneteenth. He then read the Proclamation aloud.

CONSIDERATION OF RESOLUTION NO. R-2024-3321, A RESOLUTION DEMONSTRATING WASHINGTON COUNTY'S SUPPORT AND APPROVAL OF TRT FUNDING FOR MATCHING FUNDING FOR THE UTAH OFFICE OF TOURISM CO-OP MARKETING PROGRAM

Greater Zion Marketing Manager Sara Otto explained there is an annual co-op funding process from the Utah Office of Tourism, and this Resolution will affirm that Washington County will match up to \$250,000 in matching funds to attract out of state visitors to Washington County.

CONSIDERATION OF RESOLUTION NO. R-2024-3322, A RESOLUTION APPROVING A MARKETING SPONSORSHIP AGREEMENT WITH BLACK DESERT RESORT

Sports and Adventure Manager Chad McWilliams explained that Black Desert Resort is scheduled to host annual PGA and LPGA tournaments beginning in 2024. Greater Zion has negotiated an agreement for marketing sponsorship with Black Desert Resort, including placement at events and over 50 commercials on the golf channel.

John Coolbaugh with Black Desert Resort relayed the excitement of the Black Desert team for the upcoming events.

Koko Head, full time managing council for Black Desert, mentioned upcoming developments in the Black Desert area, including homes and restaurants.

Dani Eilander discussed her excitement to live in Washington County full time and to be a part of Black Desert.

Mr. Snow stated that Santa Clara-Ivins animal shelter has space available for sheltering animals that have been picked up within Washington County and are willing to provide limited impound or sheltering services.

CONSIDERATION OF RESOLUTION NO. R-2024-3324, A RESOLUTION APPROVING AN AMENDED AGREEMENT WITH WEST PUBLISHING CORPORATION FOR LEGAL RESEARCH SERVICES

Mr. Snow related that this is an amended contract to provide legal research services used by the Washington County Attorney's Office.

Motion by Commissioner Iverson to Adopt Resolution No. R-2024-3324, A Resolution Approving an Amended Agreement with West Publishing Corporation for Legal Research Services. Motion seconded by Commissioner Snow and carried by unanimous vote, with Commissioners Almquist, Iverson, and Snow voting aye.

CONSIDERATION OF RESOLUTION NO. R-2024-3325, A RESOLUTION APPROPRIATING FUNDING FOR ENGINEERING SERVICES ON PHASE 1 OF THE ZION CANYON SEWER EXTENSION PROJECT

Regional Tourism Regulatory Affairs Director Heath Hansen explained the Utah Legislature previously appropriated \$18 million dollars to the County to fund the Zion Canyon sewer extension and trail expansion project. Ash Creek Special Service District and Sunrise Engineering have negotiated to complete engineering design services for the first phase of a sewer line extension. This resolution provides for the county's reimbursement of costs for the design services.

MOTION:

Motion by Commissioner Snow to Adopt Resolution No. R-2024-3325, A Resolution Appropriating Funding for Engineering Services on Phase 1 of the Zion Canyon Sewer Extension Project with \$202,100 going to Sunrise Engineering and \$5,000 going to Ash Creek Special Service District. Motion seconded by Commissioner Iverson and carried by unanimous vote, with Commissioners Almquist, Iverson, and Snow voting aye.
