Trish DuClos summarized the staff report. Wasatch Regional is applying for a subdivision to be able to get a separate address. This will be an area where they turn waste into natural gas and will pump it into the Dominion pipeline. Our code states you can only have one address per parcel.

There was discussion about which code requires a separate parcel for a different address. Trish stated it's in the county GIS code. Ron Elton asked about the addressing for strip malls. Trish stated that they can have different suite numbers or separate buildings can have unit numbers. But the main address needs to be the same for 911 services.

Ron asked the applicant about needing a separate address. The applicant stated they have been working on this for a long time. Ron asked Trish if she could refer him to the code that requires this. Trish stated during the subdivision process, there are agency review meetings where all the required departments make sure their own code requirements are being met.

There was discussion about the required improvements necessary regarding streets and sidewalks. Trish stated that most of the county has swales. We don't require curb and gutter.
