

**MINUTES OF THE BOARD OF CANVASSERS FOR THE JUNE 25, 2024
PRESIDENTIAL PRIMARY ELECTION,
HELD ON JULY 8, 2024, BEGINNING AT 1:00 P.M.
IN THE COMMISSION CHAMBERS IN DUCHESNE, UTAH**

PRESENT: Commissioner Chair Irene Hansen, Commissioner Tracy Killian, Deputy Attorney Tyler Allred, Clerk-Auditor Chelise Jessen; Election Specialists Cristina Neilson, Commissioner Assistant Melissa Hughes, and Commissioner Greg Miles is appearing via ZOOM

The Board of Canvass convened at the designated place and time.

Duchesne County no longer has polling locations throughout the county. It is an ALL-BY-MAIL/ABSENTEE County. Registered Republicans were mailed a ballot. All ballots were counted before July 8, 2024, in preparation for the canvass on Monday, July 8, 2024.

There are 7,661 active Republican voters in Duchesne County. There were 7,661 By Mail/Absentee ballots issued to voters for Duchesne County. 4,109 ballots were processed by mail, of which 30 residents moved out of the County, 123 ballots had no forwarding addresses, 34 ballots were forwarded to new addresses, 4 ballots were on temporary away, and 59 ballots were postmarked after June 24, 2024, for a total return ballot count of 4,359. Additionally, to the 4,109 ballots returned, there were 3 provisional ballots, 53 ballots were in-person votes, and there were 45 signatures not cured, for a total ballot count of 4,120. Giving us a 53.78 % turnout.

Commission Chairman Irene Hansen declared the election official and the results final.
