Ms. Lartigue reminded the Commission that the Commission training would be held separate from the Commission meeting in May. Ms. Lartigue shared that she had received two nominations for Chair and two nominations for Vice Chair. She added that of the nominations only one nominee in each position accepted the nomination. She shared that Vice Chair Morales accepted the nomination for Chair, and Commissioner Woodbury accepted the nomination for Vice Chair.

**VICE CHAIR MORALES:**

Vice Chair Morales shared an update on the Citizenship Path that 19 of 20 participants have made it through the program and will graduate on April 3<sup>rd</sup>. He also shared that on March 28<sup>th</sup> there would be a ceremony at Union Station, and the program would run next year.

**DIANA LOPEZ:**

Ms. Diana Lopez, Community Program Coordinator, shared the Ogden City Police Department would hold an event on May 20<sup>th</sup> at the Dinosaur Park and invited the Commission to attend. She also shared there would be an additional event at Neptun Skating on June 20<sup>th</sup>, and a Night Out Against Crime event on August 13<sup>th</sup>. She invited the Commission to attend the citizens police academy training.

Vice Chair Morales asked questions about the demographics of the training class. A conversation ensued.

**LINDA LARTIGUE:**

Ms. Lartigue shared Mayor Nadolski had informed her he would be running behind and apologized for the inconvenience. She also shared that there would be a change to the internal process of how she would communicate recognitions to Council Staff and that nominations would need to be made two months in advance going forward.

Mayor Nadolski addressed the Commission to share his sentiment that he wanted to build a community and advance a future for the people who live in Ogden City. He shared that he did not want to replace Ogden, but to enhance it. He emphasized that it was important to him that residents get immediate and direct connections to the opportunities and programs available to them. He asked the Commission for questions. Chair Jones asked Mayor Nadolski how he would envision the Commission work with him and what he needs from the Commission. Mayor Nadolski answered that he hoped the Commissioners would use their position to be leaders in the community and would get to know the needs of the community to encourage community members to participate and connect with opportunities. A conversation ensued. The Commission thanked Mayor Nadolski, and Chair Jones expressed her desire to establish a good line of communication and work together.
