NOTICE OF THIRD VIRTUAL SCHEDULING

The Public Service Commission (PSC) held a second scheduling conference on rehearing on July 11, 2024. During the conference, the Division of Public Utilities (DPU) and the Office of Consumer Services (OCS) each stated they are working through the State of Utah Division of Purchasing's procurement process to retain qualified expert witnesses and the process is taking longer than anticipated. Both DPU and OCS requested the PSC notice a scheduling conference for a month after July 11, 2024 to allow them the additional time needed to retain their witnesses. Rocky Mountain Power did not object to the DPU's and OCS's request.

Accordingly, the PSC will conduct a virtual scheduling conference on **Monday, August 12, 2024, at 1:00 p.m.** Parties should come prepared to discuss the process for adjudicating the schedule on rehearing.
