RESOLUTION 2024 -06**

**A RESOLUTION APPOINTING A COMMUNITY GROWTH COMMITTEE**

**WHEREAS**, the City Council has proposed the establishment of a community committee, to be called the Spring City Planned Growth Committee (the “Committee”) to consider and prepare a growth plan for Spring City, for presentation to the City Council; and

**WHEREAS**, the Spring City Planned Growth Committee is to consider, and prepare a plan for growth in and around Spring City, including the identification of any areas that may be suitable for consideration of subdivision into building lots smaller than the 1.06 acre standard lot, or for development of homes for residences of various income levels, and providing input regarding potential revisions to the recently adopted Spring City ordinance regarding the creation of a new R-MF residential zone (the “Plan”); and

**WHEREAS**, the Committee is to prepare the Plan for presentation to the City Council no later than September 30, 2024 (the “Delivery Date”); and

**WHEREAS**, the Plan will be subject to review, modification and approval by the City Council.

**NOW THEREFORE, BE IT RESOLVED** by the City Council of Spring City as follows:

1. That the Committee is established, to consist of such of the following individuals as may accept the responsibility, and such other individuals as may be designated by the Mayor and Council Member Randy Strate:

2. That unless otherwise determined by the Mayor or City Council, the Chair of the Committee will be Ken Krogue.
3. The Committee Chair may recommend other community members to the committee to be approved by the Mayor and Council Member Randy Strate or persons to serve on subcommittees, or to provide information or resources and may dismiss committee members that he feels are not contributing to the Plan. The City Council desires that the committee continue to represent all segments of the community.
4. That the Committee is charged to prepare the Plan no later than September 30, 2024, for presentation to the City Council.

5. That the City Council will have the authority to review, modify, approve or reject the Plan.
6. That if at any time before September 30, 2024 the Committee determines that it cannot complete a Plan for presentation to the City Council, it will promptly notify the Mayor.

## RESOLUTION 2024-07

### SETTING FORTH SALARY FOR JUSTICE COURT JUDGE FOR THE CITY OF SPRING CITY BY THE SPRING CITY COUNCIL

**WHEREAS**, the City Council of Spring City recognizes the need for a salary for the Justice Court Judge; and

**NOW THEREFORE**, be it ordained by the Council of Spring City, in the State of Utah, as follows:

**SECTION 1: ADOPTION “2024-06” of the Spring City Municipal Resolutions is hereby *added* as follows:**

#### ADOPTION

##### 2024-06 Salary for Justice Court Judge (*added*)

Section 78A-7-206 of the Utah Code allows each city or county to set the salary of its full-time justice court judge(s). As such, the annual salary of a district court judge will be increased to \$213,900 effective July 1, 2024. At that point, the salary of a full-time justice court judge will need to be between \$149,730 and \$192,510.

For courts with part-time judges, this range is reduced in proportion to the judge's workload. The workload for the Spring City Justice Court was calculated by the Administrative Office of the Courts to be 5% of the workload of a full-time justice court judge. Therefore, the salary range for the Spring City Justice Court Judge is \$7,486.50 to \$9,625.50.

The Justice Court Judge's salary cannot change due to fluctuations in the workload, a judge's salary cannot be lowered during his/her term of office.

The Justice Court Judge will be paid \$7,500 per year or \$625 per month.

**Section 1. Adoption:** That the Fiscal Year 2024-2025 Budget be hereby adopted, including all funds and accounts as shown in the budget format attached.

**Section 2. Effective Date:** This Resolution shall become effective as of July 1, 2024.

ORDINANCE 2024-08**

**AMENDMENTS TO TITLE 7 CHAPTER 2 – TREE REGULATIONS**

**WHEREAS**, the Spring City Council has considered needs to revise provisions of Title 7, Chapter 2 of the Spring City Municipal Code relating to the planting and maintenance of trees planted within the street right-of-way; and

**WHEREAS**, the City Council has proposed for adoption modifications to Title 7, Chapter 2, Tree Regulations, to provide for agreements between the landowner and the city to impose responsibilities on the landowner with respect to the planting and maintenance of trees within the road easement;

NOW THEREFORE, be it ordained by the City Council of Spring City, Utah, as follows:

**SECTION 1: Amendment of Section 7-2-5 – Tree Planting.**

Section 7-2-5 of the Spring City Municipal Code, titled “Tree Regulations,” is hereby amended to read in its entirety as set forth below, with new language added, as indicated.

**7-2-5 TREE PLANTING**

- A. Forest Plan: Street tree plantings must conform in species and location with the city community forest plan established by the beautification commission or be otherwise permitted by an agreement with the city. No species other than those included in the forest plan may be planted as street trees or park trees without written permission of the commission, or as permitted in an agreement with the city and trees may only be selected from the tree list that corresponds to the specific proposed tree location as designated in the forest plan. The planting of street trees may be conditioned on the property owner entering into a contract with the city regarding the maintenance and removal of the trees and compliance with the requirements of this Chapter.
- B. New Developments: In the case of new residential, industrial or commercial development (of any size or type), the developer shall be responsible for new street tree planting. The developer shall be responsible for the purchase and

planting of trees in the public right of way no smaller than one and one-half inch (1 1/2") caliper, which conform in species and spacing to the forest plan as provided by policy written by the beautification commission and approved by city council, and SCMC 7-2-6, "Tree Spacing" and SCMC 7-2-7, "Distance From Street Corners And Fire Hydrants". (Ord. 2010-02, 7-3-2010)

**Effective Date:** This ordinance shall be in full force and effect immediately upon the required approval and posting or publication according to law.

### AGREEMENT REGARDING PLANTING AND MAINTENANCE OF STREET TREES

This Agreement Regarding Planting and Maintenance of Street Trees (this “Agreement”) is made and entered into effective as of \_\_\_\_\_, 2024 (the “Effective Date”) by and between Spring City Corporation, a Utah municipality (the “City”), and \_\_\_\_\_ (the “Resident”), who owns property within the City, located at \_\_\_\_\_ (the “Affected Property”). The City and Resident are sometimes referred to collectively as the “Parties,” and individually as a “Party.”

#### Background

A. The Resident has planted, or proposed to plant, one or more trees within the public right of way located directly adjacent to the Affected Property (the “Street Trees”), as has been disclosed to the City.

B. The Municipal Code of the City (the “Code”) restricts the planting of Street Trees without the consent of the City’s Beautification Commission (the “Commission”).

C. The City does not currently have a Commission, so the City is permitting the Resident to plant and maintain Street Trees as disclosed to the City, subject to the terms and conditions of this Agreement.

#### Agreement

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound, the Parties hereby agree as follows:

1. Planting of Street Trees. The City will allow Resident to plant Street Trees where and as has been disclosed to the City, subject to the terms and conditions of this Agreement. All Street Trees will be planted at least 25 feet from the center of the street. All provisions of the Code relating to the types and spacing of Street Trees shall be observed, including those set forth in Title 7, Chapter 2 of the Code.

2. Maintenance of Street Trees. The maintenance of all Street Trees planted pursuant to this Agreement shall be the responsibility of Resident, consistent with the requirements of the Code, including those set forth in Title 7, Chapter 2. Resident shall be keep all such Street Trees trimmed away from overhead power lines.

3. Removal of Street Trees. Should the City at any time need any of such Street Trees to be removed in order to allow for a widening of the street, or the placement or maintenance of any utilities lines, or other permitted uses of the public right of way, the Resident will either remove, at the Resident’s expense, such Street Trees in accordance with such time period as may be required by the City, or reimburse the City for such removal.

4. Obligations to Run with the Affected Property. Resident understands and acknowledges that the obligations set forth herein are to run with the Affected Property, so that if Resident transfers the Affected Property, Resident will advise the transferee of the obligations set forth herein and such transferee will be obligated to continue to fulfill such obligations.

## RESOLUTION 2024-09

### A RESOLUTION AMENDING POLICIES AND PROCEDURES UNDER UNIFORMS AND ASSESSORIES, WORK BOOT REIMBURSEMENT

- A. That the City will reimburse a City employee who purchases OSHA approved (Steel toe) work boots at a cost of up to \$200.00 every two years. The employee will purchase the boots and present the City with the receipt to be reimbursed. Only OSHA approved work boots will be reimbursed.

**ORDINANCE 2024-09**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SPRING CITY, UTAH ENACTING COMPENSATION INCREASES FOR SPECIFIC CITY OFFICERS**

**WHEREAS**, THE Utah State Legislature during the 2024 General Session passed S.B. 91; and

**WHEREAS**, S.B. 91 amended Utah Code Section 10-3-818 regarding City employee salaries; and

**WHEREAS**, the City of Spring City must now publish public notice and hold an separate public hearing on proposed compensation increases for executive municipal officers before adopting those increases; and

**WHEREAS**, the Spring City City Council finds that enacting the proposed compensation increases as set forth in this ordinance will comply with Utha Code requirements and will promote the public health, safety, and welfare of the residents of the City of Spring City, Utah.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SPRING CITY, UTAH, THAT**

**SECTION I – ENACTMENT**

The attached Exhibit A contains compensation increases for executive municipal officers proposed for inclusion in the City's Fiscal Year 2025 budget.

**SECTION II – AMENDMENT OF CONFLICTING ORDINANCES**

If any ordinances, resolutions, policies, or zoning maps of the City of Spring City heretofore adopted are inconsistent herewith they are hereby amended to comply with the provisions hereof. If they cannot be amended to comply with the provisions hereof, they are hereby repealed.

**SECTION III – EFFECTIVE DATE**

This ordinance shall take effect upon its passage by a majority vote of the Spring City City Council and following notice and publication as required by the Utah Code.

**SECTION IV – SEVERABILITY**

If any section, subsection, sentence, clause, phrase, or portion of this ordinance is, for any reason, held invalid or unconstitutional by any court of competent jurisdiction, such

provision shall be deemed a separate, distinct, and independent provision, and such holding shall not affect the validity of the remaining portions of this ordinance.

### **SECTION V – PUBLIC NOTICE**

The Spring City Recorder is hereby ordered, in accordance with the requirements of Utah Code § 10-3-710–711, to do as follows:

- a. deposit a copy of this ordinance in the office of the City Recorder; and
- b. publish notice as follows:
  - i. publish a short summary of this ordinance on the Utah Public Notice Website created in Utah Code § 63F-1-701 and on the City's official website; and
  - ii. publish a short summary of this ordinance in a public location within the City that is reasonably likely to be seen by residents of the City.
