Call to Order: The meeting was called to order at 2:15 p.m. by Chairman Hill, who recited the following:

Oath of Office: Chairman Hill thanked Trustee Issowits for his service. Attorney Rose administered the oath of office to Eric Ahern.

OTHER BUSINESS

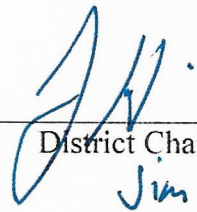
Attorney Rose reported the Trustees should sign a statement of interest consistent with Trustees of other districts. No action was taken.

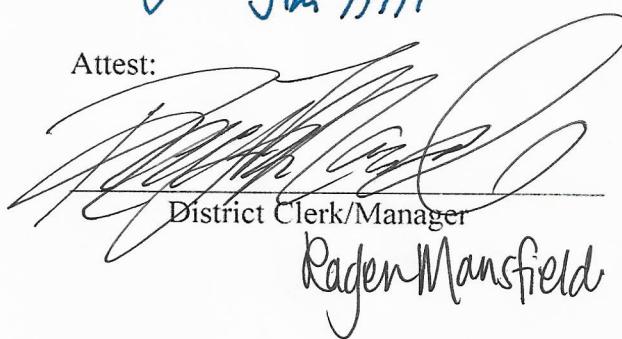
