**Comments:** Mr. Fisher said currently We Witches is over 800 square feet and single apartment 800 square feet. The proposed new facility is twice that, about 1600 square feet and two apartments above that. The distance between the two buildings is about 6 feet and gated for privacy and private entrances with good lighting. Insists on applicant obtaining a survey and will fit in as much parking as possible. Has a proposed layout for the coffee shop. Stairs will be enclosed on the east side.
