Establishing the Office of Data Privacy

- The Office of Data Privacy has initially been established as an office with the Department of Government Operations.
- Christopher Bramwell has, pending confirmation by the full Senate, been appointed by Governor Cox as Chief Privacy Officer and director of the Office.
- The CPO reports directly to Marvin Dodge, Executive Director of the Department of Government Operations and Chair of the Utah Privacy Governing Board.



Staffing the Office of Data Privacy

Initial staffing of the Office of Data Privacy, including transfers and new hires, includes:

- Micah Vorwaller, JD, Deputy Chief Privacy Officer
- Denise Farnsworth, JD, PLS, Privacy Architect
- Brian Nelson, Privacy Analyst
- Shane Otvos, Privacy Training Director

Additional positions to be staffed include:

- Data Privacy Ombudsperson
- Additional privacy personnel based on needs identified during project implementations



Strategic Data Privacy Plan

- The Strategic Privacy Plan fulfills a requirement of Executive Order 2023-06 and Utah Code § 63A-19-301, directing the Chief Privacy Officer (CPO) and the Office to create and maintain a strategic data privacy plan.
- The plan is in final stages of edits, review, and approval and the Office anticipates presenting parts of the plan to the Utah Privacy Governing Board on August 29th.
- Thank you to commissioners McCown, Smith, and former commissioner Farnsworth who have individually provided feedback, critiques, and contributions to the plan as it has been worked on over the last 14 months.
- If interested, the Office would be pleased to meet with commissioners to review the plan and allow for an opportunity to provide input prior to August 29th.
