Comments or Concerns

Kelli Bellon from Myton thanked Director Weight for the buffer and not fogging in front of her home. She requested clarification on the chemicals that are being used. Short discussion about the mixture used. Charlie Strebel advised her that she can google Control 30/30 and get all of the SDS data about this chemical. Kelli stated she has been in contact with the Tribal Mosquito Abatement, they use a different chemical. Discussion about whether to fog or not to fog, diseases carried by mosquitoes, the threat of West Nile Virus, and the confirmed human cases in Myton last year.

(Annette McRae entered the meeting at 7:39 p.m.)

Kelli continued by saying she is the recipient of a grant and needs to keep good records. She lives on the river and plans to plant additional habitat. She is not asking the District to not fog, just asking to try something different. She is concerned the mosquitoes become resistant and stronger.

Director Weight stated he has to do what is best for the whole County. Kelli went on to say she is doing something different and it feels like it is working for her. It's just a concern, insecticides may not be the best way to control West Nile.

Alan Haslam will be taking the annual audit report prepared by Aycock & Miles, reviewing it, and reporting at the August meeting.

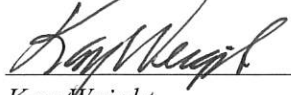
Director Weight said he is currently short a couple of employees, the ones he has right now have been here a couple years and are doing an excellent job.
