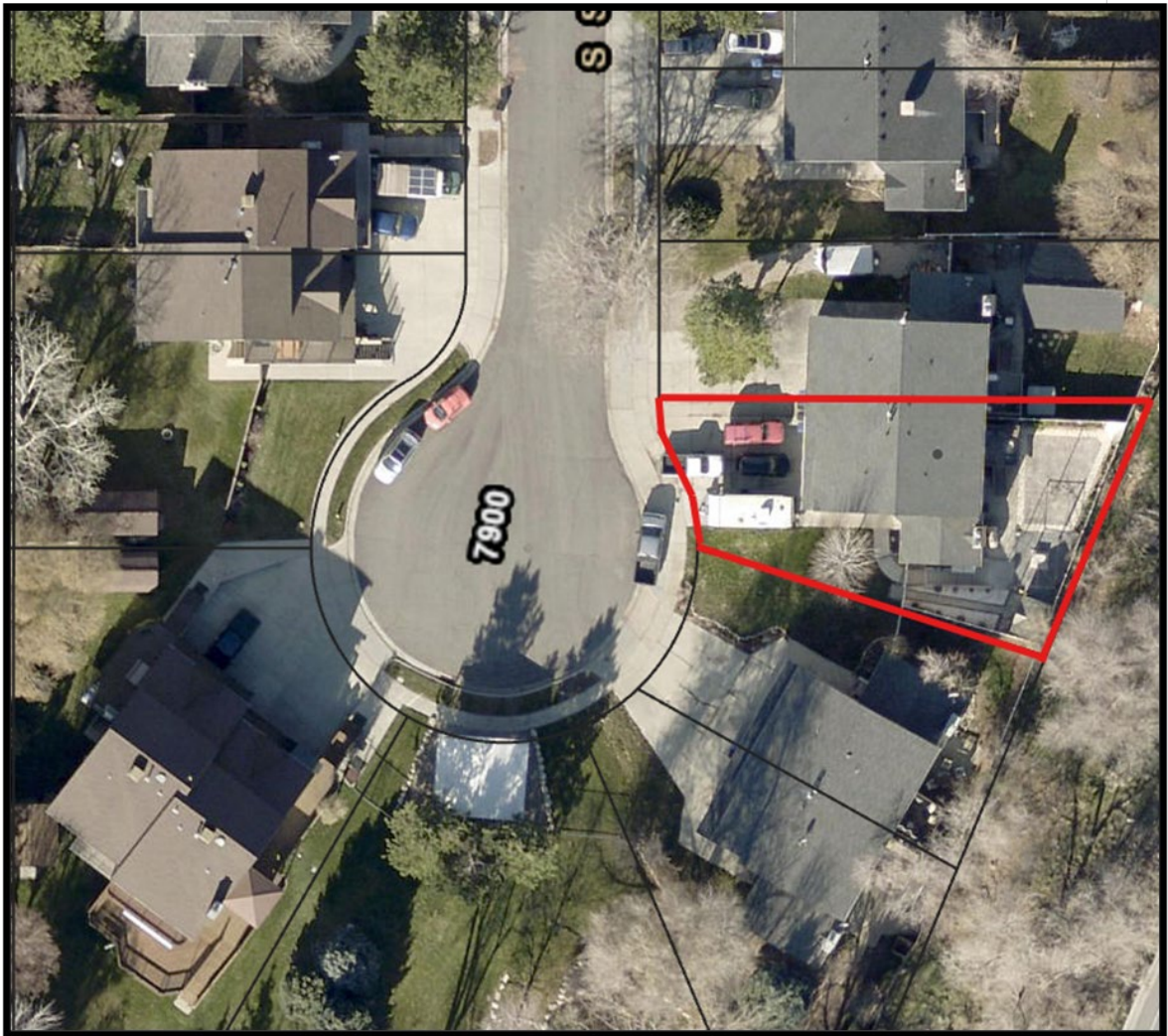
How Can I Learn More about the Project?
