Welcome/ Meeting Called to Order

Commissioner Roger Brian welcomed all and called the meeting to order.

Approval of Minutes- Commissioner Scott Bartholomew made a motion to approve the minutes from the May 15, 2024 Executive Board Meeting. Commissioner Greg Jensen seconded the motion. Motion approved.

FYI- Ms. JaLyne Roundy announced that Ms. Pam Morrison is now the co-director of the HCAP department and explained that Ms. Morrison will replace the current director upon her retirement.

R6 Programs, Ongoing Projects & Reports

CIB Application Reviews- Mr. Tyler Timmons told the board members that the CIB applications were included in their packets so they can follow along. He explained that CIB requires the Executive Board to review all applications for projects in the region and vote supportive of the project, non-supportive of the project, or neutral. Each community advisory explained the projects in their respective counties. Ten applications were reviewed by the board:

Commissioner Greg Jensen made a motion to support all the applications as presented. Commissioner Clinton Painter seconded the motion. Motion approved.

Policies and Procedures Approval- Ms. JaLyne Roundy told the group that the Policies and Procedures for R6 Regional Council are identical to the Six County AOG Policies and Procedures. Commissioner Reed Hatch approved the Policies and Procedures for R6 Regional Council. Commissioner Greg Jensen seconded the approval. Motion approved.

Action: No action needed

Transportation Plan Approval- Mr. Jess Peterson explained that in order for the agency to be awarded state and federal transportation funds, there needs to be a transportation plan in place. He let board members know that the R6 plan is the same as the Six County AOG plan that was updated in 2023. A survey was sent out to the eligible entities in the region asking for new projects. Responses to the survey are due tomorrow. The survey responses will be added to the plan before it is submitted to UDOT. Commissioner Scott Bartholomew made a motion to approve the plan as presented, provided that it includes the survey responses. Commissioner Clinton Painter seconded the motion. Motion approved.

Senior Nutrition Program Update- Mr. Doug Kirkham reminded the county leaders that he and Ms. Sharon Bullard are still available to provide assistance with the senior nutrition program. He told a story that illustrated how important the program is for homebound seniors.

Central Utah Agri-Park Update- Mr. Shaun Kjar told the board that he continues to work with the landowner. He let them know that some big decisions will need to be made soon regarding the water contract.

Forest Service RAC Update- Mr. Brock Jackson thanked the board members for their applications and told them he hasn't heard any feedback from the Forest Service at this point.

Utah Outdoor Rec Initiative- Mr. Jackson shared some information about the Outdoor Recreation Initiative and asked board members to help recruit members for the Regional Recreational Council.

Congressional Briefing Update- Commissioner Scott Bartholomew gave an update about the tour. He asked any board members to contact Travis if they are planning on attending the August 13 ride and could offer rides.

Ephraim City DEQ Grant Letter- Ephraim City Manager Sean Lewis told the group about the project Ephraim is working on with Intermountain Health. There is a need for an environmental study on some of the land involved. There is funding available for the study, but a third party will need to apply. Mr. Lewis asked if R6 Regional Council would be the applicant. He explained that there will not be any cost or risk to R6 Regional Council. There were questions asked and answered. Mayor Justin Seely made a motion to approve the request. Commissioner Greg Jensen seconded the motion. Motion approved.

PLPCO- Mr. Shea Owens updated the group on several issues including a NEPA challenge, Chevron Doctrine, Uintah Basin Railroad issues, and travel management plans.
