Call to Order – Mayor Ken Phippen

Mayor Ken Phippen called the meeting order.

#1 - Opening Ceremony

- a. Consider approval of a business license for Vestco Plumbing and Mechanical

- b. Consider approval of a conditional use permit for a construction business for Caleb Stoker at
1309 North 1200 West

DAVID JAY MOTIONED TO APPROVE A CONDITIONAL USE PERMIT AS LONG AS HE GETS WRITTEN APROVAL FROM PROPERTY OWNER FOR A CONSTRUCTION BUSINESS FOR CALEB STOKER AT 1309 NORTH 1200 WEST. TIM SHUPE SECONDED THE MOTION. A ROLL CALL VOTE WAS TAKEN WITH TIM SHUPE, DAVID JAY AND BOB BLIND ALL VOTING AYE. MOTION PASSES UNANIMOUSLY.

- c. Consider approval of the Farr West Family Dental site plan for Brad Butterfield located at
1407 North 2000 West

- d. Consider approval of Ordinance No. 2024-17, creating the new Innovation Commercial Zone (ICZ)

BOB BLIND MOTIONED TO APPROVE ORDINANCE NO. 2024-17, CREATING THE NEW INNOVATION COMMERCIAL ZONE (ICZ). TIM SHUPE SECONDED THE MOTION. A ROLL CALL VOTE WAS TAKEN WITH TIM SHUPE, DAVID JAY AND BOB BLIND ALL VOTING AYE. MOTION PASSES UNANIMOUSLY.

- e. Discussion/Action – Recycling Program

Ken Phippen spoke about the Recycling Program and stated they are no longer recycling. He asked what we would like to do for the future. The Council determined to end the recycling program.

TIM SHUPE MOTIONED THAT THE CITY PROCEED WITH RENEGOTIATION TERMS WITH RECYCLING TO GET OR OF CONTRACT. DAVID JAY SECONDED AMENDED AS LONG AS THEY ACCEPT THAT THE CANS ARE LEFT OR TAKEN. A ROLL CALL VOTE WAS TAKEN WITH TIM SHUPE, DAVID JAY AND BOB BLIND ALL VOTING AYE. MOTION PASSES UNANIMOUSLY.
