*Emigration Canyon Community Council (ECCC)*

**Bill Tobey** stated the ECCC drafting migration process to reorganize the ECCC under the metro township council.

*Unified Police Department (UPD)*

**Detective Dawn Larsen** stated there were 27 calls for service in January, with 15 initial reports. SportsAM is holding its race on April 6, 2024, for 200 racers. The duel radar has been installed in her vehicle.

*Unified Fire Authority (UFA)*

**Chief Bryan Case** stated January had a low call volume. UFA is tracking several legislative bills. Recruit camp 57 started with 34 recruits, and camp is now down to 27 recruits. The 2024-2026 strategic plan was recently adopted. Over 90 meetings were held with various communities and stakeholders to get the plan where it is today. He reviewed recent retirements and promotions. The safety message for the month reminds residents to keep things away from furnaces and use portable heaters responsibly.

*Emigration Canyon Name and Logo/Legislation Converting Townships to Cities and Towns*

**Cameron Platt** stated H.B. 35 – Metro Township Modifications, has passed. Emigration Canyon will officially convert to a city on May 1, 2024. All ordinances and resolutions will convert and business will continue as usual.

**Deputy Mayor Hawkes** asked what would happen to the clerk services.

**Mr. Platt** stated the city will need to hire a clerk/recorder.

**Mayor Smolka** stated there is a short amount of time to come up with a new city logo and name. Does the Council have any suggestions?

**Council Member Harris** recommended sending a survey out to residents to get their input on city names. A postcard will be sent to residents explaining the conversion to a city, it would be good if it could include name options.

**Deputy Mayor Hawkes** suggested upgrading the logo to make it more modern. It can be tweaked a little bit but does not need to be redone.

*H.B. 374 – County Sheriff Amendments*

**Cameron Platt** stated separation of the Unified Police Department (UPD) and the Sheriff's Office is scheduled to take place on July 1, 2024. The Council should decide which law enforcement agency it will go with in March or April.


