Issue Updates: Commissioner Lytle said he didn't have anything on RDA or MBA and assumes that the processing of the Loan is going forward. The search for the missing paddle boarder at Swim Beach this past Saturday is ongoing this morning. Commissioner Tippets expressed his condolences for the family dealing with this tragedy.

Commissioner Asay said the loss on the Clinic was up last month with the PA being on maternity leave and Doctors covering. There were some meetings last week regarding the new Clinic and they went well.

Sheriff Bailey came into the meeting and explained the search and all the efforts that have been ongoing trying to find the missing paddleboarder. They have had lots of help and support from other agencies including a very supportive local crew.

Commissioner Tippets said there was a contract with Burdick last week, as they were doing some repairs and they were able to do some of the work needed for about $2\frac{1}{2}$ miles last week. James went to the Road District meeting last Thursday and they funded all of about \$600 of the request, so

the Purchase Request on the list for today is withdrawn. Commissioner Lytle said there were some flooding issues on Brown's Park Rd due to the heavy rains the other day.

Citizen Comments: Sydnee Lamb, Ericka Wall and Sara Bell of TriCounty Health Department said they are trying to get more involved with Daggett County and the residents. It was asked what they could do to help and be involved. The Commissioners acknowledged that their Director is involved with the new clinic. Commissioner Lytle noted that they could do more on social media locally and could get involved with the senior citizens and the schools. Commissioner Asay said he hasn't always shared everything that the Health Department is doing to help out our community. They have been reaching out and it was suggested that they do the newsletters for the Town of Manila and also the Daggett County newsletter. The Facebook page for Dutch John Yard Sales and the Manila Classifieds page was mentioned as a great resource to reach a lot of people in our communities.

Sheriff Bailey brought up that with the passing of Ned Brady recently we found out that we no longer have any hospice care here. TriCounty doesn't really do that, but would help spread the word to the different agencies.

Another issue that was brought up was the alcohol and vaping issue and the Parents Group is getting involved and they will be represented at the PRCA Rodeo. The tobacco compliance checks need to continue as that is important. Underage usage is a problem everywhere, not just in Daggett County. It would be great to have the Health Department involved in the Parent Group.

October 9th is the date for the Daggett County Flu Shoot Out this year. They want to serve as many people in the County as possible. The County is hoping that TriCounty Health will continue to ramp up things before the Clinic is finished, so it will be used and helpful to the community. The Commissioners encouraged TriCounty to work closely with the Towns and they said they would. Commissioner Lytle asked if the Towns were involved with the TriCounty Health Department Board and Commissioner Asay didn't think so. TriCounty will be here on Saturday for Daggett Days. The Portable Mammogram Bus (which is not affiliated with TriCounty Health) is a possibility, but it is unclear if it will be here or not.

Cash Summary Report & Aging Report Review: The Cash Summaries and Accounts Receivable Reports were provided by the Recorder/Treasurer's Office. Commissioner Lytle noted that the Treasurer will have to do her magic as the General Fund is looking a little low.
