1. Meeting Called to Order/Adopt Agenda

2. Public Hearing: Proposed Resolution RDA24-03; a resolution of the Board of Directors of the Syracuse City Redevelopment Agency approving the Syracuse WDC Gateway Community Reinvestment Area (CRA) Project Area Plan and Budget.

A staff memo from the Community and Economic Development (CED) Director explained six taxing entities have been asked to participate, and have agreed to participate, in the Syracuse WDC Gateway CRA: Davis County, Davis School District, North Davis Sewer District, Mosquito Abatement District-Davis, Syracuse City, Weber Basin Water Conservancy District. Each of the taxing entities has agreed to enter into an interlocal agreement with the RDA. The six interlocal agreements, although similar, are not identical because some of the taxing entities required different provisions – Noah will be able to explain the differences. The RDA needs to pass the attached six resolutions authorizing the RDA Chair to sign the six interlocal agreements.
