Dakota Midkiff:

The establishment of the Community Service Officer Program (CSOP)

Community Service Officers (CSO's) will be responsible for provided support services to Law Enforcement for Town events, parades, critical incidents, etc. They will serve in a civilian capacity as volunteers to the Town of Mantua and the Mantua Police Department. Compensation will not be offered to CSO's due to the volunteer nature of the CSO position. Although CSO's will be allowed to represent the Mantua Police Department and perform support duties, they will not have Law Enforcement powers nor will they be legally permitted to execute duties exclusive to Peace Officers. High visibility vests will be provided to CSO's by the Town of Mantua and the Mantua Police Department. Uniform shirts may be purchased by CSO's at their own expense if they desire to have a uniform shirt. Equipment will be provided to CSO's on a temporary basis and as needed by the Town of Mantua and the Mantua Police Department. The Mantua Police Department will establish a policy governing the CSOP and the volunteer members therein.
