**Approval of the Minutes of the regular meeting held July 18, 2024.**

1. **Ratification of Staff Approval: a) Paint the trim on the front door and windows Iron Ore at 126 25<sup>th</sup> St and b) Relocate the existing sign from the cement pillar to the upper floor of the front façade between the two eastern windows at 210 25<sup>th</sup> St.**

Ms. Hale reported that she had approved a ratification to paint the trim on the front door, sidelights, lunette window and two round windows Sherwin Williams Iron Ore (SW7069) at 125 25<sup>th</sup> St. And she also approved a ratification to relocate the existing sign from the cement pillar on the ground floor to the upper floor of the front façade, between the two eastern windows. The sign will be installed into the existing holes or through the mortar at 210 25<sup>th</sup> St.

**A MOTION WAS MADE BY COMMISSIONER MITCHELL TO RATIFY STAFF APPROVAL TO PAINT THE TRIM ON THE FRONT DOOR AND WINDOWS IRON ORE AT 126 25<sup>TH</sup> ST AND TO RELOCATE THE EXISTING SIGN FROM THE CEMENT PILLAR TO THE UPPER FLOOR OF THE FRONT FAÇADE BETWEEN THE TWO EASTERN WINDOWS AT 210 25<sup>TH</sup> ST. MOTION WAS SECONDED BY COMMISSIONER WILSON AND PASSED UNANIMOUSLY, WITH ALL VOTING AYE.**

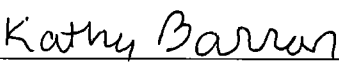
2. **Other Business:**
