## **5.2 Measuring the Results of Appropriations for Specific Programs – Program Draft Review**

The Utah State Board of Education (USBE) currently operates under performance measures mandated by legislation. However, there exists an opportunity to enhance our understanding of the impact of allocated funding by incorporating additional data and information focused on the specific benefits or positive outcomes derived from these investments, using an agreed-upon standard of measure.

This discussion is a follow up on the May 2024 Finance Committee direction to staff to move forward with a logic model that was reviewed by the committee. Staff received direction on program prioritization from the Finance Committee in August 2024 and presented draft logic models for programs that were recommended as high urgency.

USBE staff presented the draft ROI logic models to get feedback and additional direction from members of the Finance Committee on ways staff can modify the models to meet the needs of the Board. This item is a continuation of the discussion held in the September 6, 2024, Finance Committee.
