Ms. Jani Iwamoto led the Pledge of Allegiance to the Flag of the United States of America.

2. PUBLIC COMMENT

Mr. Floyd Mori spoke in support of the revitalization of Japantown, which has been a very important element of his life. Growing up, his family used to visit Japantown frequently. During World War II, there were many Japantowns in the United States, but there are not many left. Many Japanese Americans came to Utah after being incarcerated and having nowhere else to go. After the war, Salt Lake City was a haven for many Japanese Americans.

Ms. Metra Barton spoke in support of the revitalization of Japantown. Her mother lived there growing up, and her grandfather, after serving in World War II, had the address of Japantown listed on his discharge papers. She would like to be able to introduce the community to her daughter.

Mr. William Pruitt stated he was the former arborist for the County, and he has complained to the Council numerous times about how the County cares for its trees. He stated these costly assets were being seriously mismanaged and trees were dying at a significant rate as a result. Mr. Pruitt implored the Council to do three things: initiate an unbiased tree preservation board; instruct the board that the primary objective should be to create an ordinance pertaining to the care of County-owned trees; and hire a forester to oversee the care of the trees.

Council Member Granato stated she sponsored this resolution after being contacted by Jani Iwamoto, former Utah State Senator and former Council member, who made her aware of multiple plans being discussed by the Smith Entertainment Group (SEG). Council Member Granato wanted to reiterate the County's support of agreements that are already in place.

Council Member Stringham stated this cause was close to her heart because Haruko T Moriyasu, one of her college professors, was very influential in her life.

Senator Jani Iwamoto distributed and reviewed a historical summary of Japanese American history in Salt Lake City by Haruko T Moriyasu. She also provided a few letters of support for the record.

Ms. Lorraine Crouse, a retired photograph archivist from Special Collections at the Marriott Library, stated she was able to build a Japanese American photograph archive, which included photographs, manuscripts, audio-visual materials, journals, oral histories, books, and other documentation. She distributed and reviewed Salt Lake's Nihonjin Machi by Haruko T. Moriyasu, which included images of Japantown from the past.

Mr. Paul Iwasaki stated he was born and raised in the heart of Japantown. His parents owned and operated a restaurant there. He described it as a loving close-knit community where everyone knew and cared about each other.

Ms. Jeanette Misaka stated she was a California "transplant" who was an evacuee ordered to reside in an internment camp in Wyoming during World War II. Her father tried to farm in Utah, but he and his family were not welcomed. When she moved to Japantown in 1948 to attend college, it was her first experience in living in a welcoming Japanese community. The preservation of the Japanese community is very important to her. She wanted people to know that all the ethnic groups who helped to build Utah's infrastructure should be remembered. In this way, mistakes from the past would not be repeated.

Ms. Kristine Aramaki stated although she did not have experience living in Japantown in the 1960s, she still held a connection to it. It holds a special place in her heart because it is a cherished space she shares with her

WHEREAS, First South between 200 West and 300 West in Salt Lake City, renamed Japantown Street, is the location of The Japanese Church of Christ and The Salt Lake Buddhist Temple; and

WHEREAS, this area represents the last two vestiges of what was once a vibrant and thriving Japanese and Japanese-American business and cultural community; and

WHEREAS, in 1967 over 90 structures and businesses owned and/or operated by Americans of Japanese descent were mostly taken by eminent domain as part of the Urban Renewal project to build the Salt Palace, the Utah Museum of Contemporary Art; and

WHEREAS a series of expansion projects have further negatively impacted the area occupied by Japantown; and

WHEREAS, the Japanese Community Preservation Committee was created in 2000 to protect, and preserve, restore and promote the cultural community and legacy of this area; and

WHEREAS, a garden was created as a memorial to the history and culture of the area; and

WHEREAS, a Memorandum of Understanding exists between Salt Lake City and Salt Lake County for support of and access to cultural events in the area; and

WHEREAS, Senate Bill 272 passed in the General Session of the Utah State Legislature, and agreements being drafted between Salt Lake City and Smith Entertainment Group and other stakeholders will lead to major public and

private changes and investment in the area;

The Division is aware that some families have already purchased season passes for younger children. It is building in a structure to provide refunds for those passes. However, the Division will not be refunding individuals for day passes purchased. The financial cost is estimated to be \$17,000 through the end of 2024, and \$70,000 for 2025. This should not have much of an effect on the budget.

Mr. Mitchell Park, Legal Counsel, Council Office, stated it is possible to change the County seat, but this must be done in a general election. That aside, the County's elected officials must maintain an office in the County seat, but there are multiple practical ways to satisfy that requirement. The County Council is statutorily required to hold its meetings in the County seat, but it can, by vote, move its meetings to other locations in the county. Permanently moving the meetings would probably be stretching that.

Mayor Jennifer Wilson stated in acting now, the County can save taxpayers millions of dollars. The building in question is a class A building on a lot of land and is more centrally located for residents. Waiting would result in paying three or four times as much.

Mr. Darrin Casper, Deputy Mayor of Finance and Administration, thanked Megan Hillyard and her team for taking this project on. He noted the Government Center is on land that can be leased for a high amount of revenue.

RESOLUTION OF THE SALT LAKE COUNTY COUNCIL AUTHORIZING THE CONVEYANCE OF AN INTEREST IN CERTAIN REAL PROPERTY LOCATED IN MURRAY, UTAH BY QUITCLAIM DEED

RECITALS

- A. In 2010, Salt Lake County (the “County”) conveyed certain real property at approximately 882 West Greenoaks Drive, Murray, Utah, identified as Parcel ID No. 21-14-401- 022 (the “Property”), by tax deed (the “Tax Deed”) to Ramon and Aurelia B. Galvan (the “Galvans”).
- B. The Property had been listed for sale in 2010 by the County because of delinquent taxes assessed in 2005. Aurelia Galvan passed away in 2006 and Ramon Galvan passed away in 2009.
- C. It appears that the Galvans’ son redeemed or paid the delinquent taxes in 2010, causing the County to issue the Tax Deed to the Galvans.
- D. The Galvans’ son, as an appointed personal representative of his parents’ estate, conveyed the Property to Salt Lake Neighborhood Housing Services, Inc., in 2019.
- E. In Utah, a deed that names a deceased person as a grantee is void. Therefore, the Tax Deed was void when it was issued in 2010, and County needs to issue a new quitclaim deed to convey the Property. To this end, a Quitclaim Deed has been prepared and is attached hereto as Exhibit A
