Mayor Scott O'Hare said Good evening, everybody. We'd like to welcome everybody to the Wednesday, September 11, 2024, town hall meeting. My name is Scott O'Hare. I am the Mayor. We like to recognize Rod McGary, Luann Johnson, and Council Members who are present at this time. We would like to excuse Heather O'Hare, Council Member for medical reasons and an emergency and then Trish Arbon is not here right now, but she will be attending the meeting halfway through. We also like to recognize Stacey Hill, Deputy Clerk, and Tammie Morgan, our Clerk. I'd also like to recognize our president of the EMS, Dave Smith, at this time, we're gonna have Luanne Johnson say the prayer. I'm sorry. We're gonna have Luanne Johnson do the pledge.

LuAnn said I can do both.

Mayor O'Hare said do you want to do both? Okay? And then she'll follow up with the prayer.

LuAnn said I pledge allegiance to the flag of the United States of America, and to the Republic for which it stands, one nation under God indivisible with liberty and justice for all.

LuAnn said Our Father Heaven as we meet here tonight, we're thankful for the privilege we have of meeting here as friends and community members. We pray that we might have the spirit with us, that we might accomplish what we need to tonight, and that all will go well. We're thankful for the freedoms that we enjoy and we say these things in the name of Jesus Christ, amen.

Mayor O'Hare said Amen.

Mayor O'Hare said Thank you. Luann um, at the beginning of each meeting, I like to remind everybody that this is a town council meeting. This is a meeting for the town council to discuss business, for the town to make decisions, and to vote. We ask that everybody that's here witnessing this, it is an open meeting that we are not going to be talking amongst each other. If you have questions and you want to address the town council and do a question with them, we ask that you

please be put on the agenda so we can make time for you. We do make time at the end of the meeting for comments. Only. If you do have comments during the meeting that you want to make, please make sure to make a note of it, and at the end of the meeting, we will give you ample time to make that comment, but it will not be a question and answer with the town council. We appreciate your respect for this, and we thank you for that. Also, before the meeting, I'd like to recognize today is our 23, years of 911 that we have always remembered. We'd like to remember our first responders, those who

lost their lives, those civilians who lost their lives, and the families that are still suffering to this day. If we could, I would like to take just a few seconds, just for a moment of silence, for their losses.

Mayor O'Hare Thank you. And on that note, we just remember our country right now is not the best place. So we just want to make sure everybody takes their due diligence, to do their research, and make sure you get out to vote.

Whichever way you vote, that's your choice, but to please do your due diligence and please make that vote. And our thoughts and everything are with those who are running for office this year. The town council was given an email with the agenda for today and the minutes from last month. Did you receive those and be able to get a chance to look at them? Do you have anything you need to add to the agenda?

Rod and LuAnn said No.

Mayor O'Hae said Any questions on the minutes from last month? Okay? If not, I need a motion to accept the meeting agenda tonight and the minutes from last month. Wait a minute. We're gonna have to do this at the end, because we've only got two council members here, and the third one needs to be present for the vote. So we will hold all votes until the end of the meeting. Is that? Okay, Tammie, there are no additions. We have to hold the votes till Trish gets here. But it's okay to continue the meeting.

Tammie said It should be yeah.

Mayor O'Hae said until we don't have to vote on it at the beginning, correct?

Tammies said right.

Mayor O'Hare said Okay, very good. The town council was given notice. Our attorney for the town, Malone Molgard, has resigned his council for the town, beginning on October 1, 2024 did you guys? Did you guys get to see the letter that was sent?

Rod and LuAnn both said I did.

Mayor O'Hare said Okay. We'd like to make public comments that I was unaware that his uncle had passed away, or his brother, or is it his uncle, his partner? Yeah, his uncle passed away in April. I was not aware of that, but our thoughts and prayers go out to him and his family. But putting that aside, we will need new representation. I called and talked to the clerk down in Elwood and spoke with her about Elwood's representation. And they are represented by a law firm called Hayes, Godfrey, and Bell. They're out of Salt Lake City. I talked to Mr. Godfrey yesterday. They are more than willing and interested and taking on council for the town. They do. They go by either a retainer or on an hourly basis, whichever one benefits the town the best they are. They do represent multiple towns in the State of Utah, not just in Northern Utah, but throughout the State. And they are based in Salt Lake City. I do have a meeting with him tomorrow on the phone at 9:30 am to discuss further. I need to get some information from Stacey and Tammie on some stuff to have for him. For tomorrow. Does either one of you available to be on that phone call?

LuAnn asked What time is it at 9:30 in the morning until, if it is only 30 minutes, I can.

Mayor O'Hare said yeah, I don't think it's going to go much longer than that. I can call you at 9:25, and then conference him in on the call. Okay, Stacey, you'll be at work?

Stacey said yeah I will be at work.

Mayor O'Hare said Tammie, do you want to be on the call tomorrow? It'll be tomorrow.

Tammie said I have a meeting in the morning.

Mayor O'Hare said Okay, that's fine. So my question is, do you guys just want to get the information from him, bring it back to you guys, email it to you, and then does this have to be a vote for Tammie to bring in a new council for the town?

Tammie asked What is it exactly?

Mayor O'Hare said Molgard has resigned as Town Council Lawyer.

Tammie said It should be, yeah, should be.

Mayor O'Hare said to vote in a new Lawyer.

Stacey said it has to be on the agenda next month.

Mayor O'Hare said Well, we need to do it before the end of the month, because Molgard is leaving on October 1. We don't want to go without one. Will I don't think we should go any time with no representation, especially with the dealings that are going on right now.

LuAnn said Well, we have to call an emergency meeting, we can do that too.

Mayor O'Hare said but before the vote, we would have to make it a we'd to have a public hearing to hire a new attorney.

Stacey said you just have to tell the public that you guys are meeting to vote for the new Lawyer, right?

Tammie said, Yes.

Mayor O'Hare said Okay, so then we'll do that. Then LuAnn and I will talk to them tomorrow.

Tammie said you just have to, yeah, just give the proper notice to have a meeting. You can do it any time of the day, you know.

Mayor O'Hare said right, right and it's going to be, and it'll be as well as it is, is a vote. That's all it is. And if we don't have to have a public, we don't have to have a public hearing for it. So, okay. Five minutes.

Tammie said yep, five minutes.

Mayor O'Hare said Okay. We would like to welcome Trish Arbon to the meeting. She has arrived. So real quick, Trish, you received the letter in the email about our attorney resigning as attorney.

Trisha said yes.

Mayor O'Hare said Okay, so tomorrow, you work tomorrow.

Trisha said yes.

Mayor O'Hare said Okay, so LuAnn and myself will begin on a phone meeting with Lawyers out of Salt Lake City called Hayes, Godfrey, and Bell. They represent multiple towns in the State of Utah. They represent Elwood down the road. So we're going to call them. I talked to him already, Mr. Godfrey, and they're willing to take on the town as one of their clients. So LuAnn and myself will call them at 9:30 tomorrow morning. We'll get the information from them that we need for you guys, and we'll send it out in an email. Once that's done, we have to vote on it, to vote them in, we'll have to have a special meeting. It'll be five minutes, so we'll figure out a time that you guys can meet. The four of you. I may not be here and I don't need to be here for that. You guys will be the ones voting so Rod can open the meeting, you guys vote to close the meeting, and then we can call him and tell him. And then on that note, did you you receive the agenda for tonight and the minutes from last month? Did you have any additions or any questions on them? At all. Okay, all right. So in that case, now we can vote now that we have our third council member here. So I need a motion to accept the agenda for tonight and the minutes from last month. Okay,

Rod said I'll make a motion to accept the meetings from the prior month and then also the agenda for September.

Mayor O'Hare said I have a first from Rod. Do I have a second?

Trisha said second?

Mayor O'Hare said Second from Trish? All in favor.

All Town Council Members that attended said, Aye.

Mayor O'Hare said Any opposed? Passed.

Mayor O'Hare said Town Lawyers are done.

Mayor O'Hare said violations were updated. So I have both of the violations that we have out at this time, one for the cleanup of property and one for the living on the property. They've both been accepted for the signatures from the post office. Our prosecuting attorney has emailed me and asked me to send him pictures, and he needed a letter for the people living on the property. He needed eyewitnesses for that, and so I wrote a letter and told him I know for a fact they're living there, because I've talked to him about it, and so he's got all that information with that being said, he wants to indemnify our contract. Let me pull it up real quick. Indemnification. He says before he proceeds with any type of prosecution on any more cases that he needs to make a slight modification to the contract. That is, if anyone tries to sue him, the city will cover any expenses to defend that litigation. So basically, we will cover his fees for him being sued. LuAnn said should that be covered by him already? Does that make sense to you guys at his law firm?

Trisha said Usually the law firm has insurance for other lawyers.

Mayor O'Hare said So we.

Tammie said we pay trust to do that.

Mayor O'Hare said Say that again. I'm sorry. I don't mean to be rude, but we've got to keep it.

Tammie said I can call our insurance and see if that is covered.

Mayor O'Hare said okay.

Tammie said under us as well.

Trisha said he should have practicing insurance, just like a doctor or a pharmacy.

Mayor O'Hare said correct and that's what I thought, too.

Trisha said maybe he's got something else going on.

Mayor O'Hare said He does, because in the email, it says, For all the jurisdictions he represents, I've been amending my contracts to include this. I've

been a prosecutor. Well, this is what it goes I've been a prosecutor for 12 years and have prosecuted 1,000's of cases, but never once been sued. The closest I've been to being sued was in Snowville by people who live there. I'm not going to say their names, because they filed a federal lawsuit without an attorney, and they went about it the wrong way, incorrectly, so it never went anywhere. This person has already told me that they filed a lawsuit, and I told him, You do what you have to do. If you feel like you need to, you do what you have to do. So anyway. So he wants to have that indemnification clause before he starts proceeding any further with said people.

Trisha said well, aren't we changing lawyers? Anyways?

Mayor O'Hare said no, this is the different lawyers. Yeah, Rod said the prosecutor.

Mayor O'Hare said This was the one that prosecutes the towns. And my question is, if you're a prosecutor, why would you prosecute someone that could turn around and sue you? I mean, if you're going to get sued, don't you think you're going to win because you prosecuted them properly, right? I mean, or, again.

LuAnn said would ask that question tomorrow morning.

Mayor O'Hare said so yeah, we'll ask the attorneys. We're going to talk to you tomorrow if that's a practicing thing, and you can check with our insurance and see if they cover that. I've asked him to call me on the phone, Blair, and he still will not call me from the phone. I've asked him multiple times to call me. But the other violation that we have, and I don't have the book with me, it's at home, and I apologize. It's for the citizens, the person that lives in town, that we gave them six months to clean up their property. You know what I'm talking about, has texted me tonight and before the meeting and said that he's trying, to do everything we've asked him. Of course, he's given me more excuses on why it's not done. I think he's still got until October. Or is it September? Was it six months?

Stacey said it was the 19th of October.

Mayor O'Hare said the 19th of October.

Stacey said you wrote it on the calendar in the office. Mayor O'Hare said okay, so he's got until the 19th of October, so he's got another month to get it done. But then he throws in the job that, you know, I know you guys are itching to slap a fine on me and whatever, and blah, blah, blah, blah. So just so you guys know that text message came in and that.

Trisha said do what you're asked to do then you will not get a fine.

Mayor O'Hare said exactly, We just proceed forward. So, that's it for the device. Oh, the one violation that we had with a person living again on property that's supposed to I haven't been able to get contact with him yet, but I'll try to they've got two more weeks at OSI until they all go home, but I'll get a hold of him and let him know that when He comes back next year, that he'll have to go over to OSI and live on their property with his trailer if he wants to live in the trailer over in that area that's been approved.

Mayor O'Hare said Did you guys? Did I forget to send it out?

Stacey said you didn't send it to me.

Mayor O'Hare said So didn't he send it to you?

Stacey said Brandon didn't send it to me.

Mayor O'Hare said Oh.

LuAnn said he's not gonna be here.

Stacey said not today.

Mayor O'Hare said So Brandon sent an email to me. Where is it? So anyway, to finish cleaning up the trash drop site, all the concrete, you'd have to rent two different machines to do that and see if I've got it here.

Hmm, okay, I guess not, wonder where it went to.

I will get you guys over the cost because I can't find it right now. I'm gonna have to, oh, here it is, okay. So the first estimate would be \$589 which is for a mini excavator and then a hydraulic breaker to break up all the concrete. So \$589.13, and then the second one would be a skid steer to put everything in. And that one comes to \$857.51 this does not include getting Rupp's out here to take the stuff away. So we're looking at \$1,400 roughly, for just the equipment rental for him to do, and then his time, and then Rupp's. So we're looking at probably another \$2,000. I don't know if you guys want to do that this year or if you want to wait and tackle it next year.

Trisha asked What is the budget allowed?

Trisha said Why don't we see what the budget is, and then wait till next year.

Mayor O'Hare said Okay, So we will wait on budget, and then the end of this month is when the work, you know, ceases. We don't. We don't have anymore. Mowing the Cemetery in the Park is finished. That doesn't mean that we can't tell them, hey, we need something done. And if they're here, they do it. But as far as the budget goes, that's the end of the employment I should say, okay.

Mayor O'Hare said Halloween and Christmas parties. Heather wanted me to tell everybody she was sorry that she couldn't be here. Her mother was rushed to the hospital tonight, so she's at home trying to deal with stuff. So she hired Santa Claus, the same one that we had last year for an hour and a half. The price went up a little bit. But of course, everything goes up a little bit, and that's all that she's gotten into. So we need to know how we want to go about doing this Christmas party. And then do we want to do anything for Halloween?

LuAnn said I don't think so the kids go Trick and Treating. Trisha said yeah, I don't think we need to do anything.

Mayor O'Hare said okay,

Tammie said you haven't ever in the past.

Trisha No, I don't think they have.

Mayor O'Hare said they did a long time ago but I mean, there are several people. Dave said last year we did our own thing. We opened the fire station and we had hot chocolate.

Mayor O'Hare said Well, maybe we can get with Jed and if he wants to do something for the fire. The Fire Department can do something for Halloween if they want to.

Trisha said, "So does the school have a carnival or something?"

Mayor O'Hare said Wait, you're representing Jed. So, yes.

Camie Pugsley said Jed is going to be gone. I believe that's when.

Dave said it falls into the conference.

Camie Pugsley said The conference is so whoever we are all around, including myself and my kids. We are planning to make hot chocolate. We are also going to.

LuAnn asked on Halloween night.

Camie Pugsley said We're also going to get in touch with the church to see if they're planning to do a trunk or treat since it's not being done out on the flats, and if they're not, we would like to discuss trying to get one put on here.

Rod said I believe they are not.

Camie said I'm sorry.

Rod said I believe that's not happening.

Camie said I believe as well.

Mayor O'Hare said I haven't heard anything the church isn't doing anything.

Camie said not that I've been able to get a straight answer.

LuAnn asked Why did they quit doing that? The church?

Rod said Well, the rationale is that rather than do a trunk or treat, they think that the kids will do FaceTime and visit people with families.

LuAnn said I enjoy the trick-or-treaters myself.

Trisha said But here's the thing, they would do the trunk or treat and then still go around in the house. So I don't, I think a trunk or treat is pointless. I think it's for city kids, and we don't need to do that.

Camie said So I think then in that, I think that's a very good point, and I think we'll end up doing what we used to do in the hot chocolate at the firehouse.

LuAnn said on Halloween night.

Camie said Yes.

LuAnn said oh, that's a great idea.

Mayor O'Hare said So for Halloween.

Camie said it was really fun. Last year, the kids really enjoyed it. We went through, I think, 15 canisters of hot chocolate mix,

LuAnn said oh, good.

Camie said It was a lot of fun.

Mayor O'Hare said Okay.

LuAnn said I think that'd be good.

Camie said at least represents the town and its aspects.

Mayor O'Hare said and I apologize earlier, I forgot you are here representing Jed so and I apologize for stopping you, from making a comment. I just want to run the meeting like it's supposed to be done. We don't want to be here for hours like normal. But, and I apologize because the fire department and the EMS do have to say so and stuff when it comes to making decisions.

Camie said you're good.

Mayor O'Hare said So I apologize for that. Okay, so hot chocolate. Fire departments can make hot chocolate at the firehouse. The Town Hall will not do anything for the Christmas party.

Tammie asked what date was Christmas arranged for.

Mayor O'Hare said I believe it's arranged for. I want to say it's the seventh.

Let me find out from Heather.

LuAnn said let's not decorate cookies this year. Let's figure out something different to do besides decorating cookies. Or do we kids love decorating cookies? I think it's a pain in the butt.

Camie said there's too many double dipping as much as we try to

LuAnn said Yes, I think let's, let's do a different something besides the decorating cookies because that was.

Camie said that it takes a lot of time.

LuAnn said it takes a lot of time.

Trisha said I did this for my grandkids. You can get it on Amazon and they have gingerbread houses or reindeer, and it's a sticker kit. They can decorate it all to a sticker kit. It's not messy. They take it home. It's inexpensive. I don't know how many kids we have.

LuAnn said Oh, 200.

Mayor O'Hare said at the Christmas party. Who wants to be in charge of it?

LuAnn said Not the Christmas party. I helped with it last year, but I don't want to be in charge of it.

Mayor O'Hare said that's where we're at now because Heather doesn't want to do it again this year. Not that she won't. She will help.

LuAnn said, but nobody wants to. Then we don't have one anyway.

Mayor O'Hare asked if should we have it as a town hall, Town Council. Do all of us do it together?

Trisha said Or, yeah, we can put something together.

LuAnn said We can.

Trisha said we can do something, as long as Santa is coming and we do a little something. And what did you do?

Mayor O'Hare said We did it over in the firehouse last year.

LuAnn said and it was a really big deal because it took us half a day to decorate.
Mayor O'Hare said yeah.

LuAnn said and we had a really nice and everybody enjoyed it. But it is, but it's a lot of work for us. And then it's, you have to take it all down, haul it all back.
Heather killed herself trying to put everything away.

Mayor O'Hare said my sister-in-law came down. She's got a bunch of stuff, and they do parties and stuff. So they came down as

LuAnn said elaborated is that we did all the so I don't think we need to do all the juice decorating. We can have it just like we used to at a town hall. And we have Santa Claus sitting in here. We have a tree put up. We open the decorations. They come in, and we see Santa, and we give them a treat and a bag of candy, and they go home.

Mayor O'Hare said So there just be a photo with Santa that is it?

LuAnn said when I was over the Christmas party years ago, when I was on the town council, it wasn't a bunch of too much.

Rod said let's get a bunch of straw bales. And just make a little straw bale pavilion out here and have Santa's out there and serve hot chocolate and be done.

Mayor O'Hare said and you wouldn't have to do it here. Fire Department.

Camie said We as a kid, we'd have something similar. We would be outside. We'd have the heat coat, you know, the heat stuff. And kids could get a little brown sack that had oranges and peanuts.

LuAnn said that is exactly what I thought.

Camie said and keep it easy.

LuAnn said always did, I think the old-fashioned way.

Trisha said Yep, let's go back. Okay, we're doing old-fashioned Christmas.

Rod said and let Santa can give them that bag?

LuAnn said Yeah, that's what we always used to do. It was not, I mean, it was really nice last year, but it's too much work. And it was hours and hours and hours and hours and hours we were down there.

Camie said I think if we wanted to put it together.

Mayor O'Hare said when is Santa coming in?

Camie said Well, we could bring out a couple of our calves, a couple of sheep, just a couple of things that kids could come see because some of these kids that live in town don't necessarily get to see that.

LuAnn said Yeah.

Camie said but again, simple, something a little more.

LuAnn said Yeah.

Camie said then they will remember if you want something easy.

LuAnn said Yeah.

Camie said three species of animals that are super easy and broken.

Trisha said would do the old-fashioned thing,

Camie said yeah, tell them to come dressed warm.

Rod said yeah.

Trisha said and then they won't stay long.

Camie said easy, clean up.

LuAnn said seriously, that was a big job last year. It was huge.

Mayor O'Hare said Okay, she's got Santa on December 7, from 6:00 pm to 7:30 p.m.

LuAnn said Okay.

Mayor O'Hare said so old-fashioned Christmas, straw bales.

LuAnn said we'll just all come and help.

Mayor O'Hare said Eddie. Do you have any? Oh.

Tammie said he went on fire.

Camie said I think. Did they call for,

Mayor O'Hare said did they call for you guys? It's in Howell.

Dave said They're asking for Snowville.

LuAnn said Fire or?

Mayor O'Hare said fire?

LuAnn said Oh.

Trisha said there was a lot of lightning on my way home.

Camie said There are two fires in Promontory.

LuAnn said Yeah, I heard that, so lightning?

Trisha said there was a lot of lighting going on when I was here. Wind storm lightning, little rain.

Mayor O'Hare said so, old fashioned.

LuAnn said yep.

Mayor O'Hare said hay bales, hot chocolate. So we'll all coordinate together and we can get that done.

Trisha said yeah.

Mayor O'Hare said Okay.

LuAnn said good idea thank you, and then that's a lot easier than doing what we did last year.

Mayor O'Hare said Okay, perfect. Mini split pricing. We don't have the, we don't have the pricing on here, so we can't vote on it. So that's gonna be another what's the, what do we get for pricing on the mini splits?

Tammies said We don't have it.

Mayor O'Hare said We don't have it.

Stacey said no, she didn't get it.

Mayor O'Hare said Oh.

Mayor O'Hare said Box Elder. The sheriff is not here. Eric did call me today. He said there was nothing to add. He said that the CDBG grant for that is all done. He says everything's done with it.

Tammie asked with what?

Mayor O'Hare said with the CDBG grant, with the money.

Rod said for the bridge.

Mayor O'Hare said for the bridge.

Rod said it was all good and ready to go.

Tammie said He doesn't have anything to do with the CDBG grant, Eric.

Mayor O'Hare said oh, he doesn't?

Tammie said, No.

Mayor O'Hare said oh.

Tammie asked what grant is he talking about.

Mayor O'Hare said That's what he was talking about. Was the grant?

Tammie said for the bridge.

Mayor O'Hare said yeah.

Tammie said it's not all done.

Mayor O'Hare said Well, I don't know what he was talking about then.

Tammie said yeah, cuz we still have three still.

Mayor O'Hare said he was driving.

Tammie said we still have the environmental interview,

LuAnn said they brought it again yesterday for a little while.

Mayor O'Hare asked well, doesn't he do that?

Tammie said No, he's not even the engineer.

Mayor O'Hare said Sorry, sorry, I apologize.

Tammie said Yeah, Eric's not the engineer on the project. Mayor O'Hare said okay.

Tammie said UDOT has their own engineers.

Mayor O'Hare said okay, so I don't know what he's talking about, but anyway, so, but he had nothing extra. I asked about the curb and gutter. He said, the guy still hasn't gotten back to him yet. He'll reach out to him again. The box up there is the new one with the new brain and two batteries for the stoplight.

Stacey said Oh, that's what it is.

Mayor O'Hare said Yep, that's what I've been waiting on. So the manufacturer contacted manufacturers. Sorry.

LuAnn said I will tell you one thing, though, on the curb and gutter, if we are insisting on doing it in front of Mollie's they're going to shut the doors because it will shut them down if they can't park.

Mayor O'Hare said goodbye.

LuAnn said So we don't want that to happen so we're not going to let it happen.

Mayor O'Hare said well, then they need to. Then I agree with you on one point. Then they need to control who parks in front of their buildings.

LuAnn said They can't control it.

Mayor O'Hare said Well, then we'll put a curb and gutter, and that's my two cents, because I drove by there the other day to leave and I couldn't see because somebody in a U-haul decided to park right in front, and I couldn't see down that way at all, a U-haul truck?

Trisha said well let's not.

Mayor O'Hare said that's your guys' choice. Then, they need to do something. Then, I mean, come on, we offer to pay, to paint their driveway in front so they could go sideways, so the cars Park sideways, right?

Trisha said how many years do people live to park just like they park there? You could paint it. They're still gonna park the same way.

Mayor O'Hare said Okay, well, then that's fine. So that we need to make sure we have insurance, because the next time somebody has a wreck, like we just did last year and somebody gets killed then, we'll have to take care of it. So that's fine, but the curb and gutter are not for Mollie's. It's for over here, on this side, over here.

LuAnn said okay.

Mayor O'Hare said but again, it's your guys' choice. So if you guys want to not ask them to help out, then that's fine, let them do what they want.

Mayor O'Hare said Snowville, Fire Department. Does Jed have anything?

Camie said No.

Mayor O'Hare said okay, EMS.

Dave said We have the EMT conference coming up, and it's actually the end of October, very first of November, that we normally send our EMTs to get the CME training to stay certified. So I need the okay for us to go ahead and register and get the rooms like what we've done in the past, it would be 11 people if everyone goes.

LuAnn asked and now they all have to go to recertify.

Dave said Yeah, I mean, sometimes we don't get everyone there. There are some other things that they can go to at other times, this is just a good, easy way to go, take a weekend and get you can get enough CME hours to recertify quite easily by doing this.

Camie Pugsley said So Dave, I apologize, but I believe there are some extra certifications you can do as well. There's oh Jed was telling me one for we get a certified for traumatic injuries.

Dave asked while at this conference. Or is it a different one?

Camie said I believe this one that's coming up. It's either two days before or two days after.

Dave said I mean, essentially, through the conference, you get, you get credit for the classes you go to, then you can take the credit. And when you recertify, you have to have so many credits in certain areas, and so, you know, if we're paying attention, and you know where you're lacking, you can specifically go to the classes that give you credit for that. So, I mean, some of us pay attention enough ahead.

Tammie said So is that actually the 31st?

Dave said Yeah, so it starts on the 31st because that's Thursday, right?

LuAnn asked in November.

Dave said October 31st which is why we would then be here to help with the fire station, some of us the EMTs, like we did last year. But yes, it's Thursday, Friday, and Saturday in Provo.

Mayor O'Hare asked Oh, how many people, 11 people, and how much is it going to cost per person?

Dave said It's \$395, for the full Conference.

Mayor O'Hare asked which is per person.

Dave said yeah.

Mayor O'Hare said that's hotel everything.

Dave said No, that's, the registration hotels additional, although some of us bunk up together, so that saves some.

Mayor O'Hare said and the EMS has that in their budget too.

Trisha said well, don't make anybody mad you might be bunking by yourself, Dave.

Mayor O'Hare said or he might be bunking with somebody other than his wife. He and Mike will be bunking together.

Dave said Yeah. So we have the per capita grant and the last per capita grant. Those were some of the receipts that we used to be reimbursed. They turn out to be pretty easy receipts to use on that because it can the per capita grant can be used for training, and so that's typically what we've been doing. It pretty much covers it.

Stacey said but next year it will be less.

Dave said because we're a little less, yeah.

Mayor O'Hare said so you may get some money back from it, then.

Dave said well, what no per capita grant the previous year was a little higher than the one that will be.

Mayor O'Hare said oh, I got you.

Dave said to go against this.

Mayor O'Hare said Gotcha.

Dave said So, yeah, someone to come out of our budget.

Mayor O'Hare said we don't need to vote on it. Then, right? We just, this is more of an FYI.

Tammie said yeah.

Dave said whatever works for you. Yeah, we can just go ahead.

Mayor O'Hare said Yeah.

Dave asked so we could just go ahead and register.

Mayor O'Hare said yep, very good. Anything else?

Dave said No, I think that's it.

Mayor O'Hare said Okay.

Mayor O'Hare said Tammie, Snowville Clerk.

Tammie said she didn't have anything. And Deputy Clerk or Treasurer.

Stacey said I just noticed that our fire extinguishers are out of date.

Mayor O'Hare said Okay?

Stacey said So I know that Jed was called Packer's from Brigham in the past. I know it's over \$500

Mayor O'Hare said Yes, so can our fire department and our people not do this?

Stacey said No.

Tammie said usually Jed calls them and has them come out and do all of them.

Mayor O'Hare said How much does it cost for us, our fire department, to get certified to do it?

Camie said It's a whole different ball game it's like a company that actually does it.

Mayor O'Hare said no, I understand we're paying a company to come and do it, but can our own fire department certify our fire extinguishers?

Dave said we'd have to be reset up to refill.

Mayor O'Hare said So that's what I'm kind of getting at. So they've got to be recharged each time.

Dave said Now, is that what's necessarily recharged everyone but, once they're below a certain level, they have to be recharged, and you have to have the equipment to do it.

Mayor O'Hare said right, okay?

Dave said and I don't know that it would make sense for us to try to own and maintain that equipment.

Mayor O'Hare said Right, that's what I'm trying to get at. We would need equipment.

Okay?

LuAnn said the ATK Fire Department does out there.

Camie said they are full-time.

LuAnn said Yeah.

Stacey said we've had the gentleman from Brigham.

Tammie said and he's pretty reasonable.

Mayor O'Hare asked What's the county? Do you know?

Stacey said I don't know you would have to ask Jed.

Dave said good question. I mean, there's probably a certain number. If you're recertifying X amount, it might make sense to have the equipment. I don't know where.

Mayor O'Hare said I mean, since we have such a great relationship with the county and housing stuff and doing all stuff with the county, maybe they could recertify her. So \$500 for that.

Stacey said it's over that.

Mayor O'Hare said over \$500 just to come and do this.

Dave said when you did it last year, they probably did the ones.

Camie said all of them have to be done this year again.

Stacey said I thought they all had to be renewed every year.

Camie said I think these have to be checked, but they won't all have to be refilled,

Dave said the bill might be different based on how many recharged.

Stacey said So I don't know how much every year they have to be.

Mayor O'Hare said when do they expire?

Stacey said I'm not sure

LuAnn asked how many do we have. Are we counting all ones on every all the vehicles and

Dave said yeah, in the fire station, there always has to be two on the ambulance.

Tammie said I think there's some of the parkin the Bowery.

Mayor O'Hare said Yeah, we got the park. We got the Bowery.

LuAnn said oh yeah.

Mayor O'Hare said the Cemetery, yeah.

LuAnn said Cemetery?

Mayor O'Hare said They should have a fire extinguisher up there in the shed. If they don't, they need to be one. Needs to be put up there.

Camie said it says annual inspection.

Mayor O'Hare said it's annual, so we don't know how much it's gonna cost, but we need to get it done.

Rod said yeah.

Mayor O'Hare said okay.

Stacey said I'll get with Jed and see what we need to do.

Mayor O'Hare said this is something we have to vote on. Tammie said we don't, I mean, it's, I mean, it's kind of an emergency.

Mayor O'Hare said This needs to be done. That's an annual.

Tammie said you can vote on getting it done.

Mayor O'Hare said yeah.

Tammie said on the cost, but you can just make a motion to get them done.

Mayor O'Hare said Okay, so can I get a motion to get the fire extinguishers serviced for the town?

LuAnn said I make a motion to get all the fire extinguishers service that belong to the town.

Mayor O'Hare said Motion by Luann, do I have a second? Rod said Second?

Mayor O'Hare said All in favor? Aye, any opposed, passed. Okay, we can do that. Stacey, is that something Jed would call or you call?

Stacey said probably Jed did it last year, he has done it the last couple of years.

Mayor O'Hare said could you let Jed know for us that, if we could, that'd be perfect. Anything else, okay.

Mayor O'Hare said AJ, Morgan's not here. Mike, are you here on his behalf? Or did you just come to bless us with your presents?

Mike said Yeah.

Tammie said the lead and copper stuff, he got an email about doing an inventory on a couple of the locations, which he just decided to go and do himself, because they're mostly vacant lots that they're questioning. So he's working on getting that done. We did have another positive water sample last week. We had to run tests over so he's just gonna he told them he'll just take his own samples because they're gathering at Flying J.

Mayor O'Hare said yeah, they go to Flying J every single time.

Tammie said yeah, we're just gonna do our own.

Mayor O'Hare said that's what he said. If he came up with another positive, he was just gonna tell him to forget it and he'd do his own.

Tammie said Yeah,

Mayor O'Hare said perfect.

LuAnn said My house anytime too.

Tammie said yeah.

Camie said So what he said was that he will call them and we do need a fire extinguisher at the Cemetery

Shed and the lawn shed. And it's about \$500.

Mayor O'Hare said okay.

LuAnn asked if we need to get one for those.

Camie said yeah, those are the three places, and they will bring one to us.

LuAnn said okay.

Camie said so basically, three new ones.

Mayor O'Hare asked so how many samples did he say? How many samples he had, or just one sample that he needs to take?

Mayor O'Hare said we just take one somewhere in the town. Okay.

Tammie said yep. But when we take the tests over, I have to take four bottles when I know that's fine, upstream, downstream, but usually they're all downstream because that's the end of the line at Flying J.

Mayor O'Hare said Yeah.

Tammie said he has to take a source and things, and it takes forever because you have to go type them in their computer. And so anyway, he's going to start

doing, well, I'll probably end up taking but he's going to start doing it. So that's all he wanted to let you know.

Mayor O'Hare said Okay, thank you.

Mayor O'Hare said Council Member McGary, you have anything for us?
Rod said not tonight.

Mayor O'Hare said Council Member Johnson, anything for us?

LuAnn said I called the county to find out who does the crack seals, and so I've made those phone calls, but they haven't gotten back with me yet. They're going to come out and give us a bid on the two roads, really, the only two roads that we need to worry about are Stone Road and Main Street here because all the other roads we have chip seals. So we should be pretty good on those. And the reason that they're bumpy, I talked to Tyler, and he said, because the roads are so old, there's only so much they can do. All they do is put this stuff on so that we don't demolish the roads anymore. But the roads need to be ground down. On some of the bumpy roads, they need to be all the way ground down to the ground, which is what we're going to do on the one next year to the Church Road and then on the Cemetery Road, the right there, that half is going to get done next year, and then if we have the money, and then the one by the Church, they have to be all the way ground down, start from scratch and over. And there's nothing they can do about the little do-dads in the road. When they just do the chip seals, all they do is fill the potholes, chip it, and seal it. That's what they do. They don't,

Mayor O'Hare said yeah, yeah I was just wondering what it was.

LuAnn said Anderson Asphalt and Parsons are the two that are going to come to give us the bids.

Mayor O'Hare said okay.

LuAnn said The other one was from Magna, and that it would cost so much for their equipment to get out here, so I didn't have to do it, so I just went with two. Is that going to be acceptable to have both of them?

Tammie said yeah, I can just make a note that Magna was being considered, but they're coming.

LuAnn said okay.

Tammie said because they are way out of range.

LuAnn said but they're so far out that I didn't do that. But anyway, Parsons and Andersons are supposed to get back with me and make a date, and then we'll just drive around on these couple of roads. The Cemetery Road is a county road, so the county has to come to do that one. But the only two roads that I could see that needed to have the crack seals were Main Street and Stone Road.

Mayor O'Hare said the Cemetery Road is a county road.

Tammie and Stacey both said it is, yeah.

Mayor O'Hare said our border goes right before that road.

Then I thought it was after the road. Okay, that's good to know.

Tammie said I wonder too, if maybe we shouldn't do repairs after the bridge.

Mayor O'Hare said yeah, I was just getting to that.

LuAnn said I wondered that too. And so should I not have them come out? But the thing is, on Stone Road, there are some really big cracks in the middle.

Mayor O'Hare said yeah we can do Stone but that's what I would think we should suggest not doing this road until they finish that bridge because they're gonna have I don't know what subverting that way.

Tammie said I don't know what to do.

LuAnn said I don't either, but I hate to have them come out and only do one.

Tammie said yeah,

Mayor O'Hare said I wonder if we can get the county to do that road at the same time they're doing Stone, or at least do the Cemetery Road. We get Stone done that way when they close this road off because that's going to be, that's going to be the route everybody's gonna be going is down.

LuAnn said and we can do up to a certain point on this on Main Street, because they will tear up the road, but they will repair it.

Mayor O'Hare said yeah, but you're gonna have all the equipment coming through here.

LuAnn said Yeah, true.

Mayor O'Hare said that's the only thing I'm thinking about. But again, I don't know what have.

LuAnn said if we don't feel the crack seals before all the heavy equipment comes, we could demolish our road, even worse.

Mayor O'Hare said right heavy equipment isn't going to be driving. They're going to be on trailers so.

LuAnn said well, and they're going to be parking them somewhere, all their equipment, they won't be running back and forth, back and forth.

Mayor O'Hare said Oh, no, no, no, yeah. They'll park it down there. When they demolish, tear apart the bridge. And I think when they bring the new bridge in, I think it's in pieces.

LuAnn said and then he said too, that they will repair the road from whatever they dig up damage, they will replace the road with whatever's on it now, so.

Mayor O'Hare said okay.

LuAnn asked so yes or no on this road, do it to a certain point and then stop, right to my house?

Mayor O'Hare said just past your house.

Camie asked if could they give us suggestions of what they would say, you know, is there or can the county, I don't know there's someone, is there some route engineer that we can have come out and give a suggestion of yes, yeah, or like, yeah, they can hold up.

LuAnn said I'll call Tyler again tomorrow.

Mayor O'Hare said so Parsons. Parsons is one company.

LuAnn said Parson's is coming and Anderson's Asphalt.

Mayor O'Hare said okay, perfect.

Okay, anything else?

LuAnn said No, that's it.

Mayor O'Hare said okay, and Council Member O'Hare is not here. Yes, go ahead.

LuAnn said there was one more thing in my brain,

Rod said you have 10 minutes.

Mayor O'Hare said to think about it.

Mayor O'Hare said Trish, you got anything for us? Just to mention, by Morgan's dairy, where Simon owns now, there's a tree that's really hanging over the road blocking the view, my dad just mentioned it. He said he's almost had a few fatalities up there, near misses. I'm gonna go take a picture of it.

Mayor O'Hare said 800.

Trisha said Yeah, and so if it's Simon's, I'm sure we just have to mention it to him.

Mayor O'Hare said we'll let Ryan or Ryan know.

Trisha said yeah. Just have them fix it so it is not a blind stop. Anyway.

LuAnn said Oh, one other thing I had a question I had for you, Trish on, the stuff you sent us today, on the landfill. So we wanted to talk about what we were going to do with the letter that we wrote. And then at the sign. Did we get the sign made so that people are aware?

Mayor O'Hare said I'm going tomorrow.

LuAnn said Okay.

Mayor O'Hare said this is, well, go ahead, finish what you're going to say, and then I will read you the sign.

LuAnn said I just wondered how we were going to let everybody know that's what the fees were going to be. And if we type the letter, send it out with the water bills.

Trisha asked if we did not have a mass email that we do. Nobody's all signed up for email.

Mayor O'Hare said No.

Trisha said, unfortunately.

Tammie said no.

Trisha said so yeah, then that'll have to be.

Mayor O'Hare said to send it in the water bill.

Trisha said to send it in the water bill, both of these.

LuAnn said but in the letter, we also need to include the days that we plan to open.

Trisha said it was the first.

LuAnn said and the hours,

Mayor O'Hare said yeah, the first one is on that one.

Trisha said the first Saturday of every month.

LuAnn said Okay.

Trisha said so on there, just so you know how I come up with the pricing. I just went to Cache Counties, the landfill site, Weber County, and Salt Lake County.

Mayor O'Hare said so the surrounding counties,

Trisha said general and I just figured fees away from \$25 to \$50 depending, you know, that'll just have to be kind of at our discretion when we see the load and see what's going in. And, you know, I just also put on there, you know, make sure it's covered, tied down, and we can refuse the right.

LuAnn said yeah and no metals.

Trisha said that's all on the other side.

Mayor O'Hare said that's the sign we're gonna get made tomorrow.

Trisha said Okay, so anyways, I brought these two.

LuAnn said that actually a copy of that needs to go with the letter about the pricing in the water bill. They both need to be, like a front and back or whatever it just needs. We have that letter I think should go.

Trisha said yeah they both need to go.

LuAnn said what we would and wouldn't take and the days and the prices.

Mayor O'Hare said so is there a way on the water bills that we can put all of that information on? We can get it on one page, right on her, things that she's.

Tammie said yeah.

Mayor O'Hare said the things that she's got, we can make it to where we put it on a one-page piece of paper.

Tammie said can we do front and back? We can shrink it.

Mayor O'Hare said well, it doesn't have to be in that format. It could just be, you know.

Trisha said just what is on there.

Stacey said if you have prices on there you have to have that on the agenda for next time to vote on it.

Mayor O'Hare said Yeah, yeah.

Stacey said So those won't go out until November, right?

Mayor O'Hare said well, no, I mean the other one can go out, the one saying the landfills. Well, because we're gonna, that shouldn't take too long to get this sign. I don't think she didn't tell me how long it's gonna take to make it.

Camie said we put that information, I can create a Snowville town Facebook page and put that information there.

Mayor O'Hare said yeah, we've got the Snowville Town Facebook page.

LuAnn said what are we gonna do, though, about like, you know, the issue we had with the people that gather up all everybody's garbage and then want to come to the landfill. What are we gonna do with that kind of stuff? Like Truckloads?

Mayor O'Hare said I mean, it's well, the thing is, if somebody in the town goes to somebody else's house outside of town and picks up trash and their stuff and brings it to I mean, there's not much we can do. We charge them accordingly. We charge them for what they bring us, we don't.

Trisha said they are really limited in what they can bring us.

Mayor O'Hare said yeah.

Trisha said you know.

Mayor O'Hare said because we're not, we're not a full service anymore. It's just another thing.

Trisha said green waste is what it's going to boil down to, yeah.

Mayor O'Hare said green waste and regular trash, yeah?

Mayor O'Hare said So I talked to Caitlin at Mountain Valley Printing in Tremonton. So for a sign that's three feet tall, I'm sorry, four feet tall, three feet wide, pretty big sign with your hours and all that, not the one that you just sent. It's \$120 before taxes, and then it's a five to \$10 for design fee to get all your information images. They wanted to know if we have a logo they want us to put on it so we have our Utah's Outback Deer logo. I don't know if we want to put that on there or not, or if you guys just want a plain, generic sign with that information on it.

LuAnn said what is it painted? Is it?

Mayor O'Hare no, it's so it would be a,

Trisha said I'm gonna leave that up to your discretion. To get the most bang for our buck. We want something that's gonna last.

Mayor O'Hare said yeah, that's what. So this is an outside sign. It's an outdoor sign for the elements. And what they do is they put it's like almost stickers that go on it, but it's really thick. So she says, if you see these signs on the road out here in Tremonton to when you're going down, most of those signs are done by them. So she says, It's very good.

Trisha said I think we need designs on it. I think just,

Mayor O'Hare said just a plain, just the middle Snowville

The town at the top, and that's all. We don't need to have a

Trisha said Snowville waste site drop.

Mayor O'Hare said so we would be looking at between right around \$125 to \$130 for the sign. I told her, that's fine. I'll come tomorrow, and pay for it. We'll get it. We'll get it made by one of the owners, his name is Caleb, because I asked him, Do you guys also sell the posts or holders for the sign, to attach the sign to a post, to get it in the ground and all that? She said they don't. But Caleb, their owner, would talk to me about something that they have available, or somebody that might be able to do it. I don't know if we want to do it or what, but we need to get it mounted.

Trisha said I probably can scrounge up a couple of T posts out of them in the ground.

Mayor O'Hare said yeah, we just want to make sure that the sign doesn't get stolen. Somebody go out there. And you know what we have to worry about is shooting, yeah, still sign, of course.

Mayor O'Hare said Well, they stole the stop sign that one day, they stole the stop sign from down here at Cemetery Road, put it in their car, took off, and started driving down this road. This is like midnight because I got the phone call, we're out chasing this guy. And they threw the freaking Stop Sign Out the window of the car at midnight to know they stole a stop sign, um, the RV park. Oh, they were out there, and they were, they were doing something out front, doing something, and they came by through the sign. They were like, What the heck. And they chased them all the way down here, and they went flying past my house, 100 miles an hour. Oh, no, lights on. It's like, holy cow.

Stacey said one-time Klane and I found it up by Baldy when we were side by side.

LuAnn said really.

Mayor O'Hare said so my next question is, does the Town Council want to do two signs, one of each with the with well, we can't do the new one yet, until we vote on the pricing, but, and that's something we have to have a public hearing on too, right? Because we're going to be charging the public or the town.

Stacey said well, Tammie was just telling me that you could probably do this when we do this lawyer thing. Tammie said that we can have an additional meeting this month anyway.

Mayor O'Hare said yeah,

we'll just do it all at once. Yep, can you make a note of that so I don't forget So at that time? Do you guys want another sign with all the pricing on it and everything up there? Or do you want that just in the?

Camie said Scott just a note, after dealing with signs of a lot, you probably want to put two by-fours or a piece of plywood or something behind it to give it some extra girth and strength, because it will rip bolts out with the wind and it's rough, so keep some of that in consideration.

Mayor O'Hare said okay, yeah, that was my first thing. My first thought was, to have a border, at least a two-inch border on each side, all the way around the sign. And that was my first thing, was two by fours on the side inside so that you could put bolts through it, and then you put them two by fours right in the corner, or four by fours even, yeah, something in the middle. But, I mean, that's how we would put it in the ground. It's like four by fours and just drill a hole in there. I've got an order and everything.

LuAnn said I think we should have the cost posted as well on a smaller sign. Mayor O'Hare said okay, I will go ahead. Does everybody see her? The prices? Everybody is going to pretty much they're okay with those prices. So we still have a vote on it to make it legal, but I can go ahead and have the signs made that way. We're making them at the same time. Maybe we have them both. We can't post them until it's voted on but okay, was that it for you?

Trisha said Yeah, I'll get a picture of that tree. We'll talk to whoever we need to talk about it and see if we can't get that taken care of.

Mayor O'Hare said Okay, yeah, and I will, actually, I'm gonna go talk to Ryan tomorrow, because I gotta talk to her about Jose, and I will let them know about the tree, that it's overhanging, and then they it's up to them to get that tree cut down and so it's not overhanging the road. Are you gonna go take a picture of it tonight?

Trisha said probably not tonight.

Mayor O'Hare said okay, no, that's fine. I can go by tomorrow morning. I'll go by and take it that way. I can show the picture. Okay, at this time, we'd like to open the floor for public comment. We'd like to ask for three minutes per person, please. That's not set in stone, and we'll open it up for whoever has a comment.

Okay, all three people. Okay, we'll close it. The town council was emailed the town expenses from last month or not for this month, right? Stacey said Yeah,

Mayor O'Hare said this month's town expenses. Did you all see the expenses? LuAnn said Yes, I did.

Mayor O'Hare said Do you have any questions on it or anything that needs to be added or deleted? Okay? If not, I need a motion to accept expenses.

Trisha said I make a motion to accept the expenses.

Mayor O'Hare said I have a motion from Trish. Do I have a second?

Rod said Second.

Mayor O'Hare said Second from Rod? All in favor, Aye. Any opposed, it's passed. Do I have a motion to adjourn? Rod said I make a motion to adjourn the meeting for tonight.

Mayor O'Hare said Do I have a second?

Trisha said I second?

Mayor O'Hare said All in favor, any opposed, and we are adjourned. Thank you all for coming.
