**1. WELCOME**

**1.1. Call to Order**

The Off-highway Vehicle Advisory Council Chair, Jason Blankenagel called the meeting to order, and Off-highway Vehicle (OHV) Grant Administrator Rachel Toker recorded the minutes. Ms. Toker also took attendance of the council members present. With a quorum of council members in attendance, the meeting proceeded with its agenda.

### 1.2. Attendance and Introductions

Chair Blankenagel introduced himself to the council and everyone in attendance he then asked everyone in attendance to introduce themselves. Council members provided their names and affiliations for the record.

### 1.3. Approval of April 26, 2024, Meeting Minutes

Chair Blankenagel outlined the meeting's purpose, focusing on an OHV Grant applicant seeking additional funding post-support from the Outdoor Adventure Commission (OAC). He then yielded the floor to Tammy Pearson, a Beaver County commissioner, who presented the rationale for funding to the OHV council.

## 2. REVIEW AND MOTION TO APPROVE OHV ADVISORY COUNCIL BY-LAWS

Mr. Phili presented the proposed changes to the OHV Advisory Council By-Laws. Mr. Wheeler commented on needing to be made aware of the changes and Mr. Phili explained how those changes were proposed from the last meeting. Mr. Johnson proposed making additional changes to the By-Laws in certain areas of the actual appointment of the council members.

Mr. Phili advised that the council will approve these changes today to allow Mr. Christensen to vote at this meeting. Other changes will be made at a later time. Mr.

Wheeler asked a clarifying question on the by-laws regarding Mr. Christensen's tenure and how the by-laws would affect that.

**43:45      3. PUBLIC COMMENTS AND INPUT**

Chair Blankenagel opened the floor for public comments. Brett Stewart noted that the program originally had a four-person meeting to ensure transparency with the advisory council. He expressed concern over the focus on non-motorized trails by trail crews, suggesting they should prioritize motorized use. Mr. Phili explained that funding sources dictate the mix of non-motorized and motorized maintenance. Mr. Johnson emphasized wanting a more balanced approach, with motorized use being better represented.

**1:43:00      4. CODE OF CONDUCT IN MEETINGS**

Mr. Phili emphasized the importance of professionalism during meetings and encouraged council members to remain mindful of their language and behavior. He acknowledged their commitment to these standards but reminded them that all statements could be shared publicly, including on social media or in the news.

Recognizing that discussions about grant applications can sometimes stir strong emotions due to the high stakes, he suggested members pause to collect their thoughts if needed to maintain a constructive atmosphere. His goal was to set a respectful tone and ensure interactions aligned with the council's values. He concluded by reiterating that all remarks are part of the public record.

**2:15:00      6. OHVR GRANT REVIEW FOR SUMMER FY25**

Ms. Toker provided an overview of the grant applications and their structure for the council. Chair Blankenagel opened the discussion on the first project, "Trail Signs," inviting Mr. Davis to speak. Mr. Davis expressed support, noting strong community backing. Chair Blankenagel agreed, calling it a great project. Michelle Baragona suggested the funding request was too low and should be reconsidered.

The second project, "Carbon County MotoX Continued Improvements," was then discussed. Mr. Wheeler supported the project, highlighting its public accessibility, and Chair Blankenagel echoed his approval.

Next, the "Tails Equipment Side by Side" project was addressed. Mr. Wheeler expressed concern that the equipment should be used more frequently than once a month.

For the “Cold War Education at Temple Mountain” project, Mr. Wheeler noted local frustrations with BLM funding due to travel management plans closing trails but emphasized the project’s importance for preserving Temple Mountain’s history and future trail access. Bonnie McCallister raised concerns that the travel management plan could still close the road. Ms. Baragona added that even under the worst alternative, the road should remain open. Ms. Toker explained that funding BLM projects increases the chances of keeping these trails accessible.

The final project, “Color County OHV Trail Maintenance Summer 2024,” was discussed, with Mr. Johnson suggesting an increase in funding to \$2,700.

**BRODY JOHNSON MOVED FOR A MOTION TO ADD TO APPROVE \$2,700 FOR THE COLOR COUNTY OHV TRAIL MAINTENANCE SUMMER 2024. ALL WERE IN FAVOR.**

Chair Blankenagel introduced the “OHV Trail Maintenance & Repair” project, noting that all reviewers supported funding. He opened the floor for discussion, and Eric raised the question of whether the project should lease or purchase the necessary equipment.

Next, Chair Blankenagel introduced the “Logan Canyon Grooming Program” for discussion. Ms. Butler expressed concern about the lack of letters of support from the Forest Service district, which she felt reflected poor communication.

For the “Docs Beach Sign Revitalization” project, Chair Blankenagel suggested the funding seemed too low for the kiosks and recommended adding a 10% contingency. Mr. Davis agreed, stating that additional funding would be beneficial.

**BRETT DAVIS MOVED FOR A MOTION THAT THERE IS AN INCREASE OF 10% CONTINGENCY TO THE PROJECT. FRED CHRISTENSEN SECOND IT. ALL WERE IN FAVOR.**

Chair Blankenagel introduced the “Fishlake OHV Safety” project and opened the floor for discussion. Ms. Butler expressed support for the project but wanted more details on the specific items being purchased, such as safety equipment. Mr. Johnson agreed with Ms. Butler and raised a question regarding the Forest Service’s overall policy.

Chair Blankenagel asked if there were any concerns beyond helmets. Ms. Butler mentioned other items but did not specify them.

Mr. Davis said he had no major concerns but inquired about who would be conducting the CPR training.

Chair Blankenagel introduced the "Jordan River OHV Track Prep" project and opened the floor for discussion. Mr. Johnson and Mr. Wheeler asked about employee benefits. Ms. Toker clarified that while the division funds wages, it does not cover employee benefits.

Next, Chair Blankenagel moved to the "Rector OHV Trails Interpretive Signs" project. Ms. Toker provided a brief overview. Chair Blankenagel praised the project, noting the area's significance and positive intentions, and suggested increasing the overall project funding.

Chair Blankenagel introduced the "Kane County OHV Park Feasibility" project. Ms. Toker provided an overview of the feasibility study, noting that additional maps would have given a clearer picture of the project. Sheriff Curtis expressed concern about the project's anticipated growth.

Next, Chair Blankenagel introduced the "GCSAR OHV Purchase and Winter Equipment Purchase" project, with Ms. Toker explaining the details of the proposal. The council also discussed amending the budget to align with the county's OHV Search and Rescue (SAR) numbers to better reflect their needs.

**CHAIR BLANKENAGLE MOVED FOR A MOTION TO APPROVE THE GCSAR OHV PURCHASE AND WINTER EQUIPMENT PURCHASE. ALL WERE IN FAVOR.**

Chair Blankenagel introduced the next project, "Ride Right: Enjoy Enterprise Reservoir Safety and Responsibility." Ms. Toker gave a brief overview, explaining that the original applicant had to be replaced due to ineligibility. Mr. Johnson expressed uncertainty about the "patrol" aspect of the project. Mr. Phili clarified that "patrol" was a poor choice of words, as the group is not a law enforcement agency.

Mr. Wheeler asked about the source of the support letters and how the project would function. Ms. Toker mentioned that she wished the applicant had collaborated with Grand County. Chair Blankenagel noted that the project seemed more like a trail ambassador program. Mr. Wheeler emphasized the importance of support letters from OHV users, stating that they can significantly impact project approval. Ms. Toker added that such requirements could be included in the program guides she plans to update soon.

Mr. Johnson suggested the applicant reapply next year, as he felt the project needed stronger alignment with motorized users. Ms. Baragona inquired about the specific concerns. Mr. Johnson explained that the letter of support came from a non-motorized group, to which Ms. Baragona pointed out that this could be an opportunity to build relationships. Mr. Wheeler responded that the challenge lies in non-motorized groups not fully understanding motorized users.

Mr. Davis asked how many projects the applicant had received in the past. Mr. Morrison explained that Zion Forever, the group providing the support letter, has been an excellent partner and contributed significantly to previous projects.

Chair Blankenagel introduced the "San Juan County SXS Rescue" project, and Ms. Toker provided a brief overview of the grant proposal. Chair Blankenagel read a comment from Sheriff Curtis's review, noting that the county has faced funding challenges in the past. Mr. Nelson suggested that they consider seeking a different machine, as the one currently proposed is fairly expensive.

**BONNIE MCCALLISTER MADE A MOTION TO REDUCE THE FUNDING. SECONDED BY KIRK CHESTER. ALL WERE IN FAVOR**

project over the years and highlighted concerns with existing lighting. He explained that the project aims to enhance flexibility and extend operating hours, allowing for evening riding. He inquired whether state parks would be able to fund and maintain the project long-term. Mr. Wheeler raised concerns about potential noise or light ordinance issues and whether they could pose problems for the surrounding area.

Next, Chair Blankenagel moved to the "Unstoppable on Wheels: Saving Lives, One Ride at a Time" project. Ms. Toker provided an overview of the grant proposal and evaluator comments. Mr. Nelson acknowledged the need for the top-of-the-line machine being requested but suggested reducing the funding to purchase a more cost-effective option that would still meet their operational needs, arguing that the proposed machine would be overkill.

**CHAIR BLANKENAGLE MOVED FOR A MOTION TO APPROVE THE UNSTOPPABLE ON WHEELS: SAVING LIVES, ONE RIDE AT A TIME. ROLL CALL VOTE. ALL WERE FAVOR.**

Chair Blankenagel introduced the "Utah Division of Wildlife Law Enforcement Northern Region" project. Ms. Rachel provided a brief overview of the project and the evaluator's comments. Ms. Baragona expressed concern about the feasibility of using a single side-by-side to respond to 25% of the state. Ms. Butler echoed this concern, stating it could create challenges.

Mr. Phili clarified that they plan to use some Wildlife funds to purchase the machine, which would allow for patrolling; spending 50% of the funds grants them this right.

Mr. Davis noted that Sheriff Curtis had suggested in his evaluator comments that they should decrease funding so their match increases to 75%.

Mr. Phili explained how the OHV would fit into the fleet and its intended use within the division. Ms. Baragona raised concerns about the machine needing to cover unrealistic distances to respond to calls.

Chair Blankenagel asked if the council needed to revisit the "Mineral Basin Recreation Road Improvements" project. Mr. Phili expressed a desire to understand the main concerns so he could address them with the OAC and make necessary adjustments for the project to be work-ready. Ms. Toker noted that the project had been scored and reviewed highly. Mr. Nelson added that he had confirmed it is classified as a Class D road.

Mr. Wheeler inquired about who would use the road. Mr. Davis explained that about 95% of OHV users would utilize it. Mr. Phili clarified that the project had not been withdrawn; rather, further planning and exploration of other funding sources were needed.

Mr. Davis highlighted that there would be a limited window for work in the area. Mr. Phili assured the council that the project had been well-communicated and would be beneficial.

Ms. Toker mentioned the difficulty in determining the current account balance. Ms. Butler emphasized the project's importance and its status as a top priority for the area. No action was taken to approve the project, as it was withdrawn from the application process to explore other funding opportunities.

**9.1. October Site Visit**

Chair Blankenagel opened the discussion on grants and related items. Ms. Toker informed the council that the site visit had been rescheduled due to a conflict with Mr. Johnson's participation in the jamborees. She also mentioned that Brody was considering visiting Marysville to assess the fire damage there, emphasizing the importance of supporting the smaller community.

Mr. Johnson elaborated on the scheduling conflict with the original site visit planned for October 4th, which coincides with the closing day of the Beaver Jamboree, where he and Fred will be guiding. He suggested moving the site visit to either October 11 or 18. Additionally, he proposed touring Marysville to evaluate the damage from the Silver King fire.

After a thorough discussion, the council agreed that October 11 would be a suitable date for the rescheduled site visit.

**06:04:52 9.2. 2025 OHV Advisory Council Dates**

Chair Blankenagel initiated a discussion on the OHV Advisory Council meeting dates. Ms. Toker explained the rationale for the funding structure for 2025, proposing to modify the grant cycle to every six months instead of back-to-back cycles. This change aims to address the observation that fewer applications are received during the current cycle. She sought input on separating the cycles into spring and fall months to enhance participation and improve application quality, explaining that this strategic adjustment is why there are currently fewer available grants.

Mr. Wheeler raised concerns about the close timing of the grant cycles. He suggested scheduling the first cycle early in the year, ideally in January, to ensure funding is available for spring projects that rely on early-season resources.

Ms. Butler pointed out the challenges posed by simultaneous grant application deadlines, which are currently set for March. She noted that managing multiple applications during this period can be overwhelming and suggested a November deadline might be more favorable. However, she acknowledged that organizations are often focused on wrapping up summer programs and reporting during that time, which could lead to challenges in meeting application deadlines.

The council leaned toward April 25th for the next meeting date and ultimately decided on this option. Chair Blankenagel announced that the next OHV Review meeting would be held on April 25, 2025, with the location to be determined, and then entertained a motion to approve the date.

Ms. Toker noted that legislative matters might also be addressed if necessary.

To facilitate this process, she proposed a structured approach that would begin with a preliminary meeting involving staff before presenting findings to the council for final decisions.

Mr. Phili presented an overview of the trail crew's projects across all regions in Utah. He displayed a heat map illustrating the areas where the crews have been active, detailing the number of miles of trails worked on and the total projects completed.

He continued by discussing the number of course completions for education programs. Chair Blankenagel inquired about the number of citations issued this year. Mr. Phili explained that most citations have been directed toward repeat offenders. He also introduced a digital credential that individuals can carry on their phones for convenience.

Additionally, he announced the launch of a new youth course, which is longer than previous offerings, and credited Fred Christensen for his valuable contributions to this initiative. Mr. Phili also mentioned snow grooming efforts and other educational resources that could benefit side-by-side and off-road motorcycle users.

Mr. Wheeler raised a question about how the application process would be affected if he were to relocate to another state. Ms. Toker sought recommendations for improving the current grant cycle. Ms. Butler expressed her desire to be included in all Forest Service applications.
