### **2. Public Comments**

### **3. Committee Business**

Postponed: June 13, 2024, Meeting Minutes Adoption

Event Web Sites Updates: Soren Simonsen provided a brief update. He reported that the Get to the River Festival and Golden Spoke Ride events webpages have been integrated into the Commission website. There is also an updated and more user-friendly event calendar that can be sorted by categories and locations. Final approval has been received to migrate the website to a “.gov” domain.

Commission Staffing & Budget Updates: Soren reported that a new intern, Gillian Chapman, is in the onboarding process. He also noted that Festival fundraising will enable additional temporary staff during the Festival. A new full-time administrative assistant position will be opened shortly.

#### **4. Commission Events**

Get to the River Festival – September 2024: Anna Habben and Cindy Kindred provided a summary of the Festival sponsors and budget information. Soren Simonsen also provided background information about some of the relationships that have been built with certain sponsors. Several dignitaries will be attending the Festival Kick-off Event at Big Bend Nature Park & Preserve on August 30<sup>th</sup>, which will also serve as the event to publicly announce the award received from the America the Beautiful Challenge Grant.

Anna and Soren provided an overview of the Festival events that have been planned so far. Several partners are hosting their own Festival events for their staff. Cindy provided an overview of the media plan.

City Nature Challenge – April 2025 & Golden Spoke – May 2025: Julie Williams has begun to delve into these events but is currently primarily focusing on the Festival. More planning for these events will take place later in the year.

#### **5. Other Events**

Jordan River Parkway Event Guide: Soren Simonsen described the general plan for creating a community guide that will help organizers plan and execute events along the Jordan River Parkway. This guide will provide information about permitting, etc., across different jurisdictions. He reported that the Commission hopes to begin work on this in the next few months.

Roundtable Discussion: There were no additional comments.

## **6. Communications, Engagement & Outreach**

Recent Media Coverage: Soren Simonsen reported that there has been a lot of media coverage for the growing population of unhoused individuals along the River. He asked Committee members if they knew of any other opportunities to highlight the more positive aspects of the River and the work being done along it.

Upcoming Media Opportunities: Angelo Calacino mentioned that it would be beneficial to highlight improvements that have made the River more navigable and increased recreation opportunities.

Todd Munger noted that several municipalities are doing work along the River that could be highlighted, including improvements to riparian buffers.

India Nielsen Barfuss noted that asking local social media influencers may provide good opportunities.
