## **Meeting Minutes**

Eric McCulley, Chair, called the meeting to order at 10:00 a.m.

### **1. Welcome & Introductions**

### **3. Presentations & Discussion**

Great Salt Lake Basin Integrated Plan: Laura Vernon shared a presentation about the recently launched Great Salt Lake Basin Integrated Plan, including updates on the draft work plan, and next steps for this multi-year planning effort. The Basin Integrated Plan is a watershed-wide initiative jointly guided by recent state and federal legislation and funding programs. The Jordan River is one of the major tributaries to Great Salt Lake, and the Jordan River Watershed Council has been identified as a key stakeholder organization with an important role in this planning effort.

Laura reported that there are a number of social and technical challenges associated with the Plan, which is funded by both state and federal entities. Her team is working to establish a resilient water supply for Great Salt Lake and the overall watershed. The Plan will be completed by the end of 2026.

***Heidi Hoven moved to adopt the listed meeting minutes and 2024 meeting schedule. Wendelin Knobloch seconded the motion, which was unanimously approved by the Council Members present.***

Soren Simonsen noted that Governor Cox presented his proposed budget, which includes a comprehensive plan for addressing homelessness in Utah and will require approval and funding by the legislature. He also noted a federal bill under consideration that would allow for certain funds to be used for water conservation through the Central Utah Water Project.

Betty Naylor noted that the state bill regarding riparian protections is in need of clarifications on the definition of riparian before it moves forward.
