2023 Highlights

Jordan River Watershed Council

On April 12, 2023, a conditional certification of the Jordan River Watershed Council was approved by the Utah Watershed Council and was officially certified on January 18, 2024. The creation of 12 Local Watershed Councils are a part of the state's ongoing efforts to better steward our water resources. Local Watershed Councils encourage and facilitate discussion and collaboration on water-related issues and concerns among the stakeholders within the watershed as well as designate one representative to serve on the Utah Watershed Council. The watershed councils do not have any regulatory, infrastructure financing, or enforcement powers or responsibilities. Meetings of the Jordan River Watershed are held in conjunction with the bimonthly meeting of the Governing Board.

\$4.9 Million awarded for Community Driven Riparian and Wetland Restoration of the Jordan River

The Utah Division of Water Quality, along with the City of West Jordan, National Audubon Society Rockies Region, Utah State University's Utah Water Watch, and the Jordan River Commission have been awarded \$4,991,383 for several key projects focused on improving the Jordan River and its surrounding riparian areas and watershed. We are especially grateful to Utah's Senator Mitt Romney, who helped negotiate and secure this funding program in Congress, and all of Utah's 6 national delegates in Congress who provided support and assistance for the grant application.

The award will fund four primary projects:

- Restoration at Big Bend nature park and preserve
- Invasive species management and native species restoration across the Jordan River
- Wetland and upland restoration on the Gillmor Sanctuary to enhance function and shorebird habitat
- Public outreach and citizen science

Invasive Species Control and Restoration

Hired a Jordan River Vegetation Project Coordinator— Rae Robinson

In June 2023, Jordan River Commission and Division of Forestry, Fire and State Lands hired a newly-created, joint position to lead collaborative efforts to manage invasive species along the Jordan River. Rae implements and guides vegetation and habitat restoration projects on lands along the Jordan River and administers the Jordan River Cooperative Weed Management Area funds.

Supported 9 weeks of Utah Conservation Corps work along the Jordan River

Utah Conservation Corps brush cut Phragmites, controlled Russian olive and tamarisk, pulled puncturevine, removed thistles, sowed seed, and planted trees along the Jordan River at the below locations:

- Galena Soo'nkahni Preserve (Division of Forestry, Fire, and State Lands)
- Jordan River Migratory Bird Refuge, South Jordan (Utah Reclamation Mitigation and Conservation Commission)
- Pioneer Crossing Regional Park, West Valley City (Salt Lake County Parks and Recreation, Watershed Planning & Restoration Program)
- Thanksgiving Point Trailhead Park, Lehi (Thanksgiving Point)

Created best practices and tested new methods for invasive species control

- Created three Best Management Practices documents for 1. Phragmites control, 2. Russian olive and tamarisk control, and 3. revegetation along the Jordan River
- Evaluated drone spraying of herbicide on ~14 acres of Phragmites across two Jordan River locations.

Puncturevine Bounty Program

- 2,380 lbs removed

Planting & Reseeding

- 642 trees, shrubs and forbes planted in the spring and fall

Education and Outreach

Education and Conservation Paddle Events

Total Paddles: 41 | Total Participants: 1235

In addition to the public paddle events held each spring and during the Get to the River Festival in the fall, the commission's staff provides guided paddle experiences to our partner groups and other community organizations. This service offers the commission an opportunity to educate students, city and county employees, and various organizations about the Jordan River's history and ecology, as well as how to engage in recreational activities on the river safely. With our partnership with the Jordan River Nature Center, in 2023 we were able to expand our reach and engage with community members who have never had the opportunity to connect with the river in this way.

#LoveYourWatershed Initiative

The connection between stormwater and water quality isn't always visible to the public. Through the #LoveYourWatershed Initiative, the Commission has two monthly activities to both educate and activate the public around our stormwater system. On #FirstFriday, we post a challenge on social media. On #SecondSaturdays we host a cleanup along a major roadway that crosses the Jordan River.

Outreach and Education & Activities

Total Activities: 30 | Total Participants: 3223

The Jordan River Commission partners with many fantastic organizations to educate the public about the Jordan River and the watershed. We teach about the ecological systems of the river and the impact human activity has on it and what we can do to restore the natural systems of the watershed. A major focus of our outreach efforts is with the unsheltered community around the river.



