



Chelemes Way Traffic Calming

- *Speed was not a contributing factor in the tragedy of last August*
- *We hired WCG Engineers to provide traffic calming recommendations close to Chelemes Way in July 2021*
 - *Complaints for speeding in 575 E, 875 E, 2200 S, and 2300 S*
 - *85th percentile was under 30 mph*
 - *Phase 1 recommendation was striping 10' lanes (done), using speed feedback signs, and painting 25 MPH ledgers on the road*
 - *Phase 2 recommendation is to build bulb-outs and mid-block chokers. We have not made plans to incorporate phase 2.*


Chelemes Way Traffic Calming – Further Evaluation Options

- Utah's Local Technical Assistance Program (LTAP) has asked if they can help in this evaluation, separate from WCG's analysis.
 - This would require traffic counts (at the city's cost) but the recommendation and analysis from a traffic engineer would be paid for by UDOT.
- We recently hired WCG to create a Transportation Master Plan
 - Chelemes Way is one location currently slated to be researched with traffic counts for safety recommendations



Water Fluoridation

- *Davis County residents voted in favor of fluoride in November of 2000 and again 2004*
- *Court ruling out of Northern District of California*
- *Weber Basin Position on Fluoridation*
 - *"We recommend that the Davis County Health Department put an immediate pause on water fluoridation"*
- *Two cities have responded to WBWCD*
 - *Both cities suggested following the health departments direction*
- *Put to a Vote or EPA Rule Change?*




Youth Court

- *Syracuse Youth Court (SHS, SJH, WPJH, Jr. #18)*
- *Time Commitment*
- *Financial Obligation?*
- *What violations are referred (traffic, low level misdemeanor without restitution)?*
- *Justice Court and Juvenile Court*
- *Adult Advisor*

Train Quiet Zone

- *2007 Quiet Zone Agreement*
 - *FrontRunner was catalyst*
 - *Woods Cross is the “lead” representing the cities on the original north line of the FrontRunner (Salt Lake City to Pleasant View)*
 - *One of largest quiet zones in the nation (79 at-grade; 30 grade-separated)*
- *WX has been working with cities on deficient crossings since 2022*
- *Federal Railroad Administration notified WX on Sept 30 of suspension of Quiet Zone status, and mandating “routine locomotive horn sounding...until the quiet zone is compliant.”*
 - *Other quiet zones across the country also suspended*



Train Quiet Zone

- *Four crossings are still deficient*
 - *SLC – 1000 W*
 - *NSL – Main Street*
 - *Layton – Hill Field Road*
 - *Layton – Gentile Street*
- *Corrections are in progress, but a couple of them could take up to 18 more months to complete*
- *WX and Parametrix (consultant) are working closely with UTA and lobbying FRA for immediate reinstatement*
- *What can we do?*
 - *Wait and see*
 - *Consider our own or a smaller quiet zone*
