

PARKS, TRAILS, AND RECREATION COMMITTEE MINUTES

Wednesday, June 5, 2024 at 7:00 PM at 1020 East Pioneer Road, Draper, Utah 84020 in the Administration Conference Room.

1. **Approval of 2-7-2024 Minutes**– Motion by Ken Murdock, seconded by Doug Ovard, to approve the minutes. Motion passed unanimously.
2. **E-bike Regulations** – Greg Hilbig led discussion on various options in regulating e-bike use. Preferred option is to provide education through signage about trail etiquette.
3. **Deer Ridge Off-Leash Dog Trail Names** – Greg Hilbig reviewed potential trail names that play off dogs featured in Far Side cartoons, including “Beware of Doug” and “Rex Maneuver.” Motion by Doug Ovard to recommend the names, seconded by Jamie Pogue. Motion passed unanimously.
4. **Review: Mountain West Trails Conference** – Greg Hilbig and Brad Jensen reviewed items from the Mountain West Trails Conference that they attended last month. Topics included emergency response on trails, and adaptive mountain biking.
5. **Committee/Staff reports**

Greg Hilbig gave update on current projects, including the Lehi City Trails, Deer Ridge Off-leash Trails, fire crew work, and disc golf. Suggestion for staff to look at the drainage of steep connector road at Deer Ridge, and the need for porcupine aware signs.

Greg Hilbig reviewed issue of uphill travel on the beginning of Zooropa Trail.

Committee voiced concern about no restoration efforts currently taking place on the city open space in the land slide area.

Committee voiced concern with rogue trail improvements taking place and recommended that the city post on social media that any work on trails needs city permission.

Committee would like to consider a test area where a side downhill trail is installed at a blind corner or congested area.

July meeting to be cancelled due to being the day before Independence Day. Next meeting will be in August.

6. **Adjournment** - Motion by Jamie Pogue, seconded by Doug Ovard to adjourn the meeting. Motion passed unanimously.
