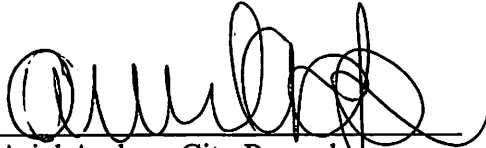
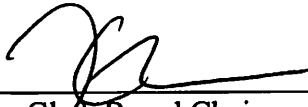
After the Closed Door meeting Board Member Campos asked about the positioning of body wraps and why they always place them facing forward rather than face down.

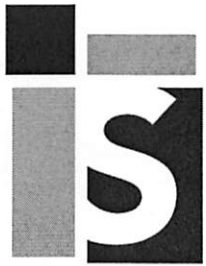

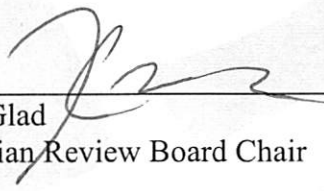
