AMENDING MONROE CITY FEE SCHEDULE**

We, the governing body of the City of Monroe, a Municipality of the State of Utah, hereby order the following resolution to be adopted and passed this 13th day of April 2021:

WHEREAS: The Monroe City Council is proposing that the rental fees for Monroe City Park Pavilions, Sport Fields, and Facilities be added or increased.

WHEREAS: Monroe City desires to increase the daily rental fee to cover park maintenance, building maintenance, and improvement costs.

WHEREAS: Monroe City, by Resolution may provide from time to time changes in fees and rates and make other regulations by resolution.

NOW THEREFORE, it is hereby resolved by the City Council of Monroe, Sevier County, State of Utah that the Fee Schedule be amended as follows.
