OAM2024-001247 – Public Hearing by the Emigration Canyon Planning Commission on the proposal to repeal and replace Emigration Canyon’s Title 18 Subdivisions. The draft ordinance has been drafted to comply with SB 174 and other legislative mandates; Replace the existing subdivision ordinance which was a copy of Salt Lake County’s ordinance; Promote ease of use by the staff and public through the use of clear and concise language and organization; and Meet the unique needs and preserve the character of Emigration Canyon. Greater Salt Lake Municipal Services District Planning Manager Brian Tucker and Jay Springer, Attorney provided an analysis of the Title 18 Amendments.

Commissioners, staff, and counsel had a brief discussion regarding difference between a concept plan and preapplication meeting with staff, subdivision improvement plan, conceptually compliant to planning commission or staff approval, development review committee identified as agencies, DRC 15-day review and comment period, definitions from 18.06.040 put in Title 19.04 but could be moved ahead of 18.06.010. Applicant needs to respond and comply to staff and DRC comments within 6 months, the application expires. Discussed septic and soils, recording the plat, legislative action, Administrative Land Use Authority refers to as the commission, any variation or exception from the required engineering standards, wildlife migrating areas, 18.12.050, paragraph b zoning conformity perk test implied, septic field and buildable area of the lot, foothill and canyon design standards renamed to Emigration Canyon design standards, 18.10.030B, paragraph 6 include existing sewers, existing septic tank, and drain field. Napkin drawings appropriate for preliminary meeting. Council directed to get rid of FCOZ and combine with site development standards.

Commissioner Wallace opened the public hearing.
