

HUNTER DRIVE RECONSTRUCTION

- Current Hunter Drive was constructed in 2007. Due to market constraints and other events, Hunter Drive has been unused and deteriorated to the point of failure.
- In 2023, Walmart submitted applications for site plan permit, subdivision plat amendment, and vacation of Hunter Drive to accommodate a development scenario of realigning Hunter Drive to accommodate a larger store.
- The realignment and construction of Hunter Drive has an estimated cost in excess of **\$4.00M**.
- Given current market conditions and the various public infrastructure costs, the development doesn't currently pencil "but-for" some sort of public assistance.
- The Developers have requested **\$2.00M** to help offset a portion of the Hunter Drive realignment cost.
- At build out the area will produce between **\$1.00M - \$1.90M** in annual City sales tax revenue.

PUBLIC REIMBURSEMENT TERMS

Walmart and Company Joint Commitments

- a. Construct Hunter Drive in the new alignment and submit documentation summarizing all costs and expenses

Walmart Specific Commitments

- a. Walmart shall receive a Certificate of Occupancy ("CO") for a Walmart Supercenter building of at least 170,000 square feet by December 31, 2027

Company Specific Commitments

- a. The Company shall construct at least 20,000 square feet of additional commercial space by December 31, 2032
- b. The Company shall redevelop Parcels 0805100401 and 080510163 within 10 years after Walmart receives CO.

City Commitments

Once Walmart and Company satisfy Joint Commitment and Walmart Specific Commitment, City shall:

- a. Reimburse Walmart for the Hunter Drive costs, not to exceed **\$2.00M**. The reimbursement shall be paid by the City from **50% of the City's local option sales tax generated from the project until the \$2.00M is reached or for a period of 8 years, whichever comes first.**

COST/BENEFIT ANALYSIS OF PUBLIC INFRASTRUCTURE APPROPRIATION

Based on the \$2.00 Public Infrastructure Reimbursement, the Development will produce a net benefit of **\$10.92M** to the City over a 10-year period. This is an average annual benefit of **\$1.09M**. The actual economic benefit of the Development is much higher due to additional direct, indirect, and induced benefits. Positive economic impacts will be felt through business, construction, and leisure supplies purchased by the Developers, businesses, and residents. It is also likely that new demand for goods and services will be attracted to the area.

SUBJECT: Amend Youth Council Committee Ordinance Regarding Youth Advisor Term



The following staff report discusses the need to amend a section of the City Code regarding establishing a term for the Youth Council Advisor:

Background

Staff found an omission in Section 32.16(E)(6) regarding the Youth Council Advisor. There are no terms outlined for the Advisor. Under the overall Committee Section, Section 32.04(A)(4) states, “*Terms.* Unless otherwise noted in this chapter, the term of committee members shall be three years...” However, the Youth Council Advisor is not a committee member.

Recommendation

The recommendation by staff is that Section 32.16(E)(6) of City Code should be amended to include a term of three years for the Advisor, and that the Advisor can be appointed by the Mayor for consecutive terms, with the advice and consent of the City Council.

ORDINANCE NO. 37-2024

AN ORDINANCE OF WEST HAVEN CITY, UTAH, AMENDING A SECTION IN THE CITY CODE REGARDING THE YOUTH COUNCIL ADVISOR; MAKING CERTAIN AND NECESSARY LANGUAGE CHANGES TO THE CITY CODE TO AFFECT THOSE CHANGES; AND ESTABLISHING AN EFFECTIVE DATE FOR THOSE CHANGES.

Section 1. Recitals:

WHEREAS, West Haven City (herein “City”) is a municipal corporation duly organized and existing under the laws of the State of Utah; and,

WHEREAS, in conformance with UCA § 10-3-707, the governing body of the city may revise, codify, and compile from time to time and to publish in book, pamphlet or loose leaf form all ordinances of the municipality of a general and permanent character and to make such changes, alterations, modifications, additions, and substitutions as it may deem best; and,

WHEREAS, West Haven City finds that there are times where the City Council has found it useful to form committees to help run City events or provide advice regarding certain issues with the City; and,

WHEREAS, the City Council finds that a Youth Council has been created in the City Code and provides for a Youth Council Advisor to help with the Youth Council; and

WHEREAS, currently, it is unclear in the City Code regarding how long of a term that the Youth Council Advisor shall serve since they are not a committee member; and

WHEREAS, the City Council wishes to make it clear regarding the term of service for the Youth Council Advisor; and

WHEREAS, the City Council finds that the public convenience and necessity, public safety, health and welfare is at issue in this matter and requires action by the City as noted above;

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF WEST HAVEN CITY, UTAH that:

1. **West Haven Code §32.16(E)(6)** regarding the Youth Council Advisor shall be amended. The new language is in red and attached as Attachment “A” to this Ordinance.

The foregoing Recitals are fully incorporated herein.

Section 2. Repealer of Conflicting Enactments:

All orders, ordinances, and resolutions regarding the changes herein enacted and adopted which have heretofore been adopted by the City, or parts thereof, which conflict with the provisions of this Ordinance, are, for such conflict, repealed, except this repeal shall not be construed to revive any act, order or resolution, or part thereof, heretofore repealed.

Section 3. Prior Ordinances and Resolutions:

The body and substance of any prior Ordinances and Resolutions, together with their specific provisions, where not otherwise in conflict with this Ordinance, are reaffirmed and readopted.

Section 4 - Savings Clause:

If any provision of this Ordinance shall be held or deemed to be or shall be invalid, inoperative, or unenforceable for any reason, such reason shall not render any other provision or provisions invalid, inoperative or unenforceable to any extent whatever, this Ordinance being deemed to be the separate independent and severable act of the City Council of West Haven City.

Section 5 - Date of Effect:

BE IT FURTHER ORDAINED this Ordinance will become effective on the 20th day of November 2024 and after publication or posting as required by law.

§ 32.16 YOUTH COUNCIL.

(E) *Officers.*

(6) *City Youth Council Advisor.* City Youth Council Advisor shall be appointed by the Mayor, with the advice and consent of the City Council, **for a term of three years. The Youth Council Advisor can be appointed by the Mayor for consecutive terms, with the advice and consent of the City Council.** The City Youth Council Advisor shall provide the City Youth Council with such administrative staff support and advisors as he or she deems necessary to assist the City Youth Council in carrying out its duties and responsibilities.

SUBJECT: Authorizing acceptance by the City of the Community Center (The Barn) in the Green Farm Project

The City and Green Farm Community, LLC (Nilson Homes), entered into a Master Development Agreement relating to the Green Farm Project ("MDA") and several MDA Amendments. One of the Amendments outlines that a Community Center would be designed and built by Nilson Homes, with financial contributions from both Nilson Homes and the City, and then dedicated to the City. Nilson Homes designed and built The Barn Community Center, which was substantially completed in June 2024 and, around July 2024, received a certificate of occupancy.

Since that time, Nilson Homes and City staff had identified a list of minor work to complete that was non-safety related. The final list of items to be completed or corrected occurred when Nilson Home and City representatives walked through The Barn Community Center on September 17, 2024. Nilson Homes has completed this final list of items. City staff believe that Nilson Homes has completed or corrected all the items on the list and recommends that the City Council formally accept the facility as complete.

Resolution No. 48-2024

RESOLUTION OF WEST HAVEN CITY AUTHORIZING ACCEPTANCE BY THE CITY OF THE COMMUNITY CENTER IN THE GREEN FARM PROJECT; AUTHORIZING THE MAYOR TO SIGN THIS RESOLUTION; AND, PROVIDING FOR AN EFFECTIVE DATE.

SECTION I – RECITALS:

WHEREAS, the City Council of West Haven City (herein "City") is a municipal corporation duly organized and existing under the laws of the State of Utah; and,

WHEREAS, in conformance with the provisions of UCA § 10-3-717, the governing body of the City may exercise all administrative powers by resolution regarding promoting and protecting the health, safety, and welfare of the public; and,

WHEREAS, the City and Green Farm Community, LLC, ("Developer") entered into a Master Development Agreement relating to the Green Farm Project (hereinafter the "MDA") effective as of May 2, 2017; and

WHEREAS, the parties amended the MDA in November 2018 (the "First Amendment"), in July 2019 (the "Second Amendment"), in September 2022 (the "Third Amendment"), and in November 2023 (the "Fourth Amendment"); and

WHEREAS, the MDA and the Amendments outlines that a Community Center would be designed and built by the developer, with financial contribution from the City, and then dedicated to the City; and

WHEREAS, the developer has designed and built the Community Center and it has received a certificate of occupancy; and

WHEREAS, the City's staff has reviewed the Community Center and its grounds and has found it to be acceptable; and

WHEREAS, the City Council finds that the City should now accept and maintain the Community Center; and

WHEREAS, the City finds that the public convenience and necessity requires the actions herein contemplated,

NOW, THEREFORE, BE IT RESOLVED by the City of West Haven as follows:

SECTION II. :

1. That the Community Center located within the Green Farm Project and delineated by the Green Farm Project MDA and its accompanying amendments is hereby accepted by the City Council; and it is officially to be maintained by the City.

2. That the City Manager is authorized to sign any and all documents necessary to affect the acceptance of the Community Center in the Green Farm Project.
3. That the Mayor is authorized to sign this Resolution.

The foregoing recitals are fully incorporated herein.

SECTION III. PRIOR ORDINANCES AND RESOLUTIONS:

The body and substance of any and all prior Resolutions, together with their specific provisions, where not otherwise in conflict with this Resolution, are hereby reaffirmed and readopted.

SECTION IV. REPEALER OF CONFLICTING ENACTMENTS:

All orders, and Resolutions with respect to the changes herein enacted and adopted which have heretofore been adopted by the City, or parts thereof, which are in conflict with any of the provisions of this Resolution, are, to the extent of such conflict, hereby repealed, except that this repeal shall not be construed to revive any act, order or resolution, or part thereof, heretofore repealed.

SECTION V - SAVINGS CLAUSE:

If any provision of this Resolution shall be held or deemed to be or shall, in fact, be invalid, inoperative, or unenforceable for any reason, such reason shall not have the effect of rendering any other provision or provisions hereof invalid, inoperative, or unenforceable to any extent whatever, this Resolution and the provisions of this Resolution being deemed to be the separate independent and severable act of the City Council of West Haven City.

SECTION VI. DATE OF EFFECT

This Resolution shall be effective immediately upon its passage on the 20th day of November 2024.

SUBJECT: Declaring a dumpster, water dispenser, TV cart, and emergency radios as surplus property



The City Council must declare City property surplus before selling or disposing it. City staff request that the Council consider declaring the following property surplus.

Water Dispenser. There is a water and ice maker dispenser within the City Hall break room. This unit no longer makes ice, and the employees do not use the water dispenser, preferring to use the drinking fountains with a dispenser to fill water bottles. It is proposed that this unit be declared surplus.



TV Cart. Within the Mount Ogden Conference Room was a TV mounted on a TV cart. Recently, City staff had the TV mounted on the wall in this conference room as the cart was damaging the sheetrock and the cart was consuming space within the conference room. The City now has no use for the cart and recommends it be declared surplus.



Dumpster. In 2021 the City impounded a dumpster that had been abandoned on a City street. The City has been storing the dumpster since then, and no one has come forward to claim the dumpster in three years, even after a diligent search and repeated attempts by the City. The City finds that it

can no longer store the dumpster, that it has been abandoned property after a significant amount of time has elapsed, and that it needs to be deemed surplus property.

Emergency Services Radio. The City owns three emergency services radios it no longer needs because they are incompatible with the Weber County Sheriff's Office's radios. It is proposed that this unit be declared surplus.

Resolution No. 49-2024

RESOLUTION OF WEST HAVEN CITY DECLARING A CERTAIN DUMPSTER, WATER DISPENSER, EMERGENCY SERVICES RADIOS, AND TV CART AS SURPLUS TO THE CITY'S NEEDS; AUTHORIZING THE SELLING OF SUCH SURPLUS PROPERTY; AUTHORIZING THE CITY MANAGER TO SIGN ALL DOCUMENTS NECESSARY TO EFFECTUATE THE DISPOSAL OF THE PROPERTY; AND AUTHORIZING THE MAYOR TO SIGN THIS RESOLUTION; AND, PROVIDING FOR AN EFFECTIVE DATE.

SECTION 1 - RECITALS:

WHEREAS, the City Council of West Haven City ("City") is a municipal corporation duly organized and existing under the laws of the State of Utah; and,

WHEREAS, in conformance with Utah Code ("UC"), the governing body of the City may exercise all administrative powers by resolution; and,

WHEREAS, the City finds that it owns a dumpster since it was abandoned on City streets in November 2021, the City has been storing the dumpster since that time, and no one has come forward to claim the dumpster in three years even after a diligent search and repeated attempts by the City; and

WHEREAS, the City finds that it can no longer store the dumpster, it is abandoned property after this significant amount of time, and it needs to be deemed surplus property; and

WHEREAS, the City finds that it owns a water dispenser located in the employee break room that it no longer needs; and

WHEREAS, the City finds that it owns three emergency services radios that it no longer needs because they are no longer compatible with the Weber County Sheriff's Office's radios; and

WHEREAS, the City finds that it owns a tv cart that it no longer needs; and

WHEREAS, the City finds that the dumpster, water dispenser, three emergency service radios, and tv cart specifically outlined in this Resolution are deemed to be surplus to the City's needs; and

WHEREAS, the City finds that selling this dumpster, water dispenser, three emergency service radios, and tv cart via competitive bidding or transferring them to another governmental agency, under terms favorable to the City is in the best interest of the City; and,

WHEREAS, the City finds that the public convenience and necessity, public safety, health and welfare is at issue and requires administrative action by the City as noted above.

NOW, THEREFORE, BE IT RESOLVED by the City Council of West Haven:

1. The City declares the City's dumpster, water dispenser, three emergency service radios, and tv cart as surplus to the City's needs.

2. The City directs that this specific dumpster, water dispenser, three emergency service radios, and tv cart be sold via competitive bidding, transferred to another governmental agency, or disposing the surplus property under terms favorable to the City.
3. The City authorizes the City Manager to sign all contracts, agreements, or other documents necessary to complete this property disposition, and authorizes the City Recorder to sign any documents as required attesting to the City Manager having been duly authorized to enter into such arrangements for the City.
4. The City authorizes the Mayor to sign this Resolution.
5. That the foregoing recitals are incorporated herein by this reference.

BE IT FURTHER RESOLVED the foregoing recitals are incorporated herein and this Resolution shall become effective immediately upon its passage.

SECTION III - PRIOR ORDINANCES AND RESOLUTIONS

The body and substance of all prior Resolutions, with their provisions, where not otherwise in conflict with this Resolution, are reaffirmed and readopted.

SECTION IV - REPEALER OF CONFLICTING ENACTMENTS

If any provision of this Resolution shall be held or deemed to be or shall be invalid, inoperative, or unenforceable for any reason, such reason shall not render any other provision or provisions invalid, inoperative, or unenforceable to any extent whatever, this Resolution being deemed to be the separate independent and severable act of the City Council of West Haven City.

SECTION VI - DATE OF EFFECT

This Resolution shall be effective on the 20th day of November 2024, and after publication or posting as required by law.
