

Board Member Items

Heather McKee, Library Board Chair, brought documentation of contact made by Katrine Myers on Friday, November 15th using the following means:

- 10:46 a.m. – Facebook message to Heather’s personal account
- 11:00 a.m. – A text message to Heather’s personal cell
- 12:02 p.m. – A voicemail left on Heather’s personal cell phone

Heather also noted that between the time Mrs. Myers sent her Facebook message and the time she texted Heather, Mrs. Myers contacted Heather’s brother-in-law, who gave her Heather’s husband’s phone number. Mrs. Myers told Heather’s husband that she had bought calves from him in the past, but Heather isn’t certain of the validity of that claim. Her husband gave Mrs. Myers Heather’s phone number, which allowed her to text and leave a voicemail for Heather during the time she was attending a meeting and unable to answer any correspondence.

10:46 AM--Facebook

Hello, Heather! My name is Katrine Myers. I'm reaching out to you because of recent events at the library with the new director. I recently started a nonprofit offering a more flexible and outdoor based education option for special needs children with ADD, anxiety, or other conditions that make traditional schooling options unfeasible. The nonprofit model is an at cost program that utilizes public facilities (to keep costs low for families) in which to meet. I teach and organize the students along with a teaching assistant. I take no pay at all. After months of booking rooms at the library, the management staff at the library have prohibited us from further booking by means of targeted and discriminatory policies, preventing bookings by extending planning times of meetings that occurred after us, manufacturing "new" policies, and outright lying in order to accuse our group of policy infraction.

When I inquired of the new director why the manipulations and discrimination, she evaded my questions (which were presented without raised voice or vulgarity), and further, called the police and had me arrested in front of my children.

Since then, she has issued a no trespassing order on me and cancelled all future reservations of our little group of 10-14 students (regardless of me being there). Her discrimination against our group is, in my opinion, because of our conservative and Christian principles (which I would be happy to explain later).

The board meeting for today has additional policy changes for booking a room and I wouldn't be surprised if they are aimed at keeping us out forever. The nonprofit has been seriously affected by her tactics. I just thought you should know what the new director has been up to.

11:00 A.M.--Text

Hello, Heather! My name is Katrine Myers. I sent you a Facebook message (I hope you are Heather Murray McKee!) explaining to you some of the things that have been going on at the library last month that I thought the board should know about. I would be so appreciative if you could take a quick peek before the board meeting today.

I just didn't hear back so I wanted to send a voicemail. Maybe I can get a hold of you before the board meeting anyway hope you guys are doing great. Take care bye-bye..."
