WHEREAS, health literacy is defined as the degree to which individuals have the ability to find, understand, and use information and services to inform health-related decisions and actions for themselves and others (personal health literacy); and the degree to which organizations enable individuals to find, understand and use information and services to inform health-related decisions and actions for themselves and others (organizational health literacy); and

WHEREAS, health literacy is essential for individuals to make informed health decisions, effectively navigate the healthcare system, and manage their health; and

WHEREAS, health literacy empowers individuals to understand medical information, follow treatment plans, and engage in preventive health practices; and

WHEREAS, inadequate health literacy has been associated with poorer health outcomes, increased hospitalizations, and higher healthcare costs; and

WHEREAS, addressing overwhelming health literacy needs can reduce healthcare costs, improve the accessibility, quality, safety, and patient satisfaction of healthcare, and improve the health and quality of life for millions of Utahns; and

WHEREAS, public schools, librarians, healthcare professionals, insurance providers, public health professionals, community organizations, social workers, and employers play a critical role in improving health literacy through clear communication, education, accessible health information, and routinely teaching and using health literacy interventions, such as plain language and teach-back; and

Whereas, November 2024 has been declared Native American Heritage Month in Utah;

Whereas, during National Native American Heritage Month, we recognize the vast contributions made by Native Americans within Salt Lake County, the state of Utah, and across the nation; and

Whereas, Native American Tribes, such as the Goshute, Paiute, Utah, Navajo, and Shoshone tribes, have been in Utah since 1200 AD; and

Whereas, we honor and recognize Salt Lake County as an ancestral homeland of these tribes and acknowledge the land's significance as a gathering place for Indigenous peoples; and

## 2. PUBLIC HEARINGS AND ISSUANCE OF PUBLIC NOTICES

2.1 Public Hearing to Receive Public Comment About Salt Lake County's Agreement to Purchase 18.6 Acres of Real Property Located at Approximately 799 W. Coliseum Way in Midvale, Utah 24-2266

A motion was made by Council Member Bradley, seconded by Council Member Theodore, to open the public hearing. Council Member Harrison was absent for the vote.

**Ms. Megan Hillyard**, Director, Administrative Services Department, delivered a PowerPoint presentation on the Midvale office campus purchase. She reviewed an asset summary; the County's options (remodel, rebuild, or relocate); a facility condition assessment for the Salt Lake County Government Center; and a list of due diligence tasks for the County.

**Mr. John Tanner**, Sandy Hills Community Council, spoke in opposition to the Midvale purchase. He stated even though the building was 40 years old, there were many other buildings in the County that were older. He stated age was incidental, due to the expense of moving. He wondered how much maintenance had been neglected over the years. He stated many people in his neighborhood are struggling and cannot afford a tax increase. He suggested renting out one of the buildings in the Government Center, as rent would be easier to collect than taxes.

**Council Member Winder Newton** stated this was less about the age of the building and more about what would be the most cost effective. Purchasing the building in Midvale, even with the price tag, the cost for renovations, and the cost for moving, would still cost less than renovating the Government Center. This would not result in a tax increase because of the high value of the Government Center property. The property could either be sold or leased, and that revenue would pay for any bond payments.

**Ms. Rachelle Morris** spoke in support of the Midvale purchase. She stated she has met with thousands of County residents this year. One thing that has been repeatedly brought up is that there are individuals who would like County Government to be closer to where they live. Additionally, many residents have difficulty distinguishing between Salt Lake County and Salt Lake City functions. She felt this move to Midvale City would help with those concerns.

**Mr. Bart Barker** stated he served as a County Commissioner in the 1980s. He spoke about the history of the Government Center and some of the challenges at the time. Prior to building the Government Center, all County elected offices were housed at the City and County Building. The County wanted to move away from leasing and toward ownership. Being closer to the center of the valley was also a priority at the time. Rather than speaking in favor or opposition to the purchase, his intent was to watch and listen to the due diligence process and gather more information to make an informed decision.

**Council Member Bradley** stated members of a community can sometimes be quick to tear down buildings because they are “in the way.” Restoration is not always a bad idea. However, there were other considerations with this decision.

**Ms. Samantha [last name not given]** asked if the County had any plans for accommodating transgender individuals, given the passage of HB 257, sex-based designations for privacy, anti-bullying, and women’s opportunities. She wondered if any accommodations would be made for individuals who were not openly transgender to all their colleagues.

**Ms. Megan Hillyard** stated the building was designed as a call center. Readyng the building for County use will require some renovation. During that stage, the varied agency needs will be taken into consideration.

A motion was made by Council Member Bradley, seconded by Council Member Theodore, to close the public hearing. Council Member Harrison was absent for the vote.
