

BEGINNING AT A POINT ON THE NORTH LINE OF THAT CERTAIN THOMAS ANNEXATION PLAT RECORDED AS ENTRY NUMBER 132401, SAID POINT ALSO BEING S 01°09'27" W 1189.01 FEET AND N 90°00'00" E 344.78 FEET FROM THE NORTHWEST CORNER OF SECTION 24, TOWNSHIP 8 SOUTH, RANGE 2 EAST, SALT LAKE BASE AND MERIDIAN; THENCE S 89°35'29" E ALONG SAID NORTH LINE, 616.67 FEET TO THE WEST LINE OF THAT CERTAIN ROACH ANNEXATION PLAT RECORDED AS ENTRY NUMBER 61002; THENCE ALONG SAID WEST LINE THE FOLLOWING THREE (3) COURSES: 1) N 00°00'00" E 32.40 FEET, 2) S 89°40'00" E 80.01 FEET, 3) N 00°00'00" E 598.49 FEET; THENCE N89°40'00" W 36.69 FEET; THENCE N 00°00'00" E 101.85 FEET; THENCE N89°30'00" W 18.33 FEET TO THE SOUTH RIGHT OF WAY LINE OF I-15; THENCE ALONG SAID RIGHT OF WAY LINE THE FOLLOWING THREE (3) COURSES: 1) S 44°31'51" W 118.28, TO A POINT ON A CURVE TO THE LEFT WITH A RADIUS OF 13,980.00 FEET, 2) SOUTHWESTERLY 680.638 FEET ALONG SAID CURVE, THROUGH A CENTRAL ANGLE OF 2°47'23", 3) S 36°09'01" W 158.23 FEET; THENCE S 00°00'00" E 19.50 FEET TO THE POINT OF BEGINNING.


